In 2015 POTRAZ participated in the AFRICAN UNION (AU) Regional Internet Exchanges Initiative and successfully lodged a bid to host the Regional Internet Exchange. POTRAZ was awarded a USD 200,000 grant by the African Union Commission (AUC) to setup Regional Internet Exchange Point (IXP). The Grant covered Capacity Building, IXP Equipment (Routers, Switches, Servers, UPS Power Backup, Installation and Setup).

The setting up of the IXP was completed with the assistance of Nishal Goburdhan who works at Johannesburg Internet Exchange (JINX). The RIXP is housed at TelOne Exchange in the second floor. To date all Internet Access Providers are connected. The IXP has two international peers namely Packet Clearing House and Quad Nine Secure DNS. The benefit of the Regional IXP is to keep local traffic local thereby increasing speed, at the same time reduce costs and load on international transit links. In line with international best practice, the RIXP was named Harare Internet Exchange Point.

Proposal [max 400 words]

- 1. Potraz is proposing to handover the management of the IXP to the community as per the initial plan.
- 2. The HIX now needs to develop into a proper Regional IXP. In order for this to happen, there is need for it to attract more regional players to connect and peer at the IXP.
- 3. We propose to peer the Harare Regional IXP with the Zimbabwe Internet exchange in order to create a single IXP, which is attractive to international, and Regional Peers.
- 4. Various members proposed the hosting of a google a cache at the IXP. The centrality of the IXP makes it the best place to host such Content Delivery Networks and allow all service providers to have access to these CNDs faster and cheaper. It will also be an advantageous to Zimbabwe if a google cache is housed at the IXP than individual ISPs hosting their own caches, which demand more than 2GBps to fill up the Caches.
