On behalf of the International Telecommunication Union (ITU), I would like to invite you to nominate participants for **the South East Asia Regional Conference on Child Online Protection** jointly organized by International Telecommunications Union (ITU), United Nations Children Fund (UNICEF), and the United Nations Office of Drugs and Crime (UNODC), with support from the Philippines Department of Social Welfare and Development and Department of Communications and Arts (DOCA), Government of Australia from **25-27 February in Manila Philippines.**

Following the adoption of the Declaration on the Protection of Children from Online Abuse and Exploitation in ASEAN at the 35th ASEAN Summit, the Conference aims to: inspire accelerated action to enhance child online protection in the region; sensitise the high level participants on the new Declaration on the Protection of Children from Online Abuse and Exploitation in ASEAN and other key ASEAN initiatives on child online protection; provide a platform for multi sectoral delegations to identify the actions needed to translate the Declaration on the Protection of Children from Online Abuse and Exploitation into action, along with industry and NGO representatives. The Conference would provide an opportunity for governments and organizations from the region (including with regional and global experts) to learn about the latest research and initiatives related to child online protection; facilitate exchanges of ideas between global, regional, and national thought leaders on best practices for child online protection across different sectors: technology; justice; education; financial; and social welfare; encourage future-looking legal, policy, educational, and technological responses for children that can adapt to rapidly changing fields of technology such as artificial intelligence and the internet of things; provide a platform to consider cross regional and inter regional collaboration; and provide a channel to share experiences and recommendations from under-18s in the region.

Completed Fellowship Forms (Annex -4) and Registration Forms must be submitted to ITU no later than 14 January 2020.
