**Subject: ITU Regional Development Forum (RDF) for the Commonwealth of Independent States (CIS) region (26-27 March 2024), Astana, Kazakhstan**

Dear Sir/Madam,

I am pleased to invite you to participate in the **Regional Development Forum (RDF) for the Commonwealth of Independent States (CIS) Region (RDF-CIS)**, organized by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) and hosted by the Ministry of Digital Development, Innovation, and Aerospace Industry of the Republic of Kazakhstan. The forum will take place from 26 to 27 March 2024 in Astana, Kazakhstan, and will be held in hybrid format with simultaneous interpretation in Russian and English.

RDF-CIS will report on the outcomes and ongoing implementation of the World Telecommunication Development Conference (WTDC-22) held in Kigali, Rwanda in June 2022. Emphasis will be given to the five Regional Initiatives for CIS Region approved at WTDC-22 as well as other activities under the five ITU-D priority areas adopted at WTDC-22.

This year's RDF-CIS will focus on Partner2Connect (P2C) matchmaking between Member States needs and partner pledges under the P2C Digital Coalition. This initiative has so far attracted globally over 866 pledges with a value of over 37.95 billion US Dollars (as of 12 February 2024). The aim will be, together with partners, to operationalize these pledges and implement impactful projects across the CIS Region. New pledges could also be announced on this occasion.

The Annual Regional Development Forum for the CIS provides an opportunity for the exchange of views between ITU and its stakeholders including ITU Member States, Sector Members as well as other stakeholders in the CIS Region. It serves as a platform for an exchange of views on how to achieve meaningful connectivity and sustainable digital transformation in the region.
