

Executive summary of the SG 9 meeting

(ITU Headquarters from 19-23 July 2010)

Study Group 9 meeting was held in Geneva, from 19-23 July 2010 and was attended by 46 delegates from 16 countries plus 3 remote participants for question meetings.

Following WTSA-08 Resolution 2 (§B.2, Annex B), SG 9 had a joint plenary session with SG 16 and joint experts meetings for the Questions related to IPTV under the IPTV-GSI event.

1.5 Initiation of Last Call for the consented draft Recommendations J.366.x and draft J.388 (J.rtav)

In October 2006, Study Group 9 consented several draft ITU-T Recommendations. Among them were J.366.2, J.366.3, J.366.4, and J.366.7. Each of these documents incorporated by reference the technology specified within Internet Drafts that have not, as yet engendered sufficient consensus to be published as IETF RFCs.

According to the latest update, the normative references to Internet Drafts in which J.366.2, J.366.3 and J.366.7 have been recently approved and are now available as IETF RFCs. The consented draft Recommendation J.366.4 has one remaining reference to an Internet Draft “A Framework for Session Initiation Protocol User Agent Profile Delivery”. As TSB got a permission from the authors of the Internet Draft to include relevant portions of the Internet Draft within J.366.4, it is also to be forwarded to the Last Call.

Along with the above-mentioned four drafts, draft J. 388 (J.rtav) which remains also as the status of Consent due to the reference to J.366.4, can be forwarded for Last Call.

2 Study on IMT impact to cable television systems

SG 9 have decided to direct the Rapporteurs of Question 1/9, 2/9, 5/9 and 7/9 to look for any indications of impacts to cable systems (e.g. video quality, set-top box, residential gateway, cable modem) from outside radio signals such as IMT (e.g. LTE), PLC, etc. Question 14/9 will coordinate this effort within SG 9, and will communicate to SG 5, ITU-R WP5D and ITU-R WP6A with any information that SG 9 discovers.

3 J series Recommendations ingredients for testing

At the request of JCA-CIT, SG 9 collected information on “J-series Recommendations ingredients for testing” and replied to JCA-CIT. (TD377) .
