Concerning sharing policies, best practices, tools and resources:

- International and regional outreach: cooperation in learning and sharing policies, best
 practices, tools and resources takes place on the international and regional levels,
 through bilateral agreements, participation in conferences, workshops, and studies. E.g.
 this includes the initiative's participation in the safer internet day of the EU for three
 consecutive years
- Sharing takes place by leveraging local, regional and international events, such as
 Egypt's Cairo ICT where the initiative held a specialized session on privacy in February
 2010 on the occasion of the Safer Internet Day, holding more than 10 specialized
 workshops with partners on the issue during IGF 2009, including a high level honorary
 session on the topic with the first lady of Egypt (patron of the initiative) as distinguished
 guest.
- Signing bilateral agreements to forge stronger relations and a more productive dialogue with key organizations including the ITU, the UN GAID, Microsoft, Cisco and Intel as founding members in 2007, the Family on Line Safety Institute, IBM and Oracle in 2009
- Holding a continuous dialogue with the Insafe program, the Council of Europe and OECD and ensuring the representation of "an emerging knowledge society's perspective" on the subject.
- With neighboring Arab countries, through the Arab Council of ICT ministers, the Arab project "protecting youth on the internet" was drafted and approved within the Arab Strategy.
- Initiating actions to encourage further the engagement of countries that have not adopted any child safety actions, by presenting a draft proposal to the ITU council to establish the WG- CP. The group was approved and first meeting took place in March 2010
- A key component of awareness raising is the modification of educational curriculum to include sections on e-safety. This is done in cooperation with the ministry of education,

with the help of the educators' focus group and MCIT. A number of educational grades have already adjusted their curricula to mainstream e-safety education.

The Cyber Peace Initiative is relying on a Peer to Peer method of awareness raising and dissemination as related to the issues of protecting children in cyber space and to share policies, best practices, tools and resources. Accordingly, three working groups have been established to address the needs of three main categories of audiences whose involvement is instrumental in the success of any public awareness campaign related to protecting children in cyber space.

The three groups are supported by NGOs and IT companies from the partners of the initiative in terms of technical, educational and content necessary for conducting the training and awareness sessions

The ITU, UN- GAID, Microsoft, Cisco, Intel, IBM, Oracle, FOSI, Childnet International

Additional information:

- The three focus groups adopted a cascaded training model, starting with Cairo and moving to 5 Egyptian governorates. TOT takes place through NGOs in each governorate. The founders lead to the development of core groups and focus groups.
- Awareness and training is conducted by the Initiative's professionals and relies on voluntary activities of members.
- About 200,000 individuals were trained in e-safety issues between 2007 and 2010

The Cyber Peace Initiative developed an e-safety national working group to synergize existing efforts and develop the suitable national policy. The group establishes a dialogue between all concerned parties around the online safety agenda.

Concerned ministries, ISPs, NGOs and The regulator are all parts of the group. The group has a defined TOR, each entity has its plans and a full strategy is in process of formulation.

The group works on the 4 main components of e-safety:

- Legislations and self regulation
- Law enforcement
- Technology solutions
- Content creation, and awareness raising
- Education

The experience of Egypt was relayed to other countries in Africa during the consumers protection conference in august 2009 and to Arab countries in Bahrain conference in April 2010.
