1. The meeting took place on 7 September 1998 from 1430 - 1645 hrs under the chairmanship of the Rapporteur, Mr. N. Kisrawi, and endorsed the proposed Agenda for Question 9/2 (Doc. 2/024).

2. Discussions

Doc. 2/022 (Guidelines for identification of those questions of particular concern to the Development Sector) was introduced by the Rapporteur as a basic document for discussion. The meeting also considered the following documents:

3. Decisions

- 3.1 After consideration of Doc 2/022, it was agreed to adopt proposals 5.1 5.5 of this document. It was also agreed to add a new element in the general Guidelines to include Questions relevant to the future World Radio Conferences. It was further agreed that all Rapporteurs for other Questions in Study Group 2 should contribute in the work in Question 9/2. A two-day Rappporteur's meeting for the preparation of the Study Group 2 meeting is proposed to be held in June 1999.
- 3.2 Following consideration of Documents 2/009, 2/010 and 2/047, it was agreed to defer decision on the proposed Recommendations and to create a Sub-Rapporteurs Group to prepare a draft Recommendation to be discussed at the June 1999 Rapporteur's meeting and for consideration by the next Study Group Meeting. The Sub-Rapporteurs Group should take into account the work of ITU-R SG 8 Working Party A and the outcome of the Tampere Convention on the provision of telecommunication resources for disaster mitigation and relief operation as adopted by the Intergovernmental Conference on Emergency Telecommunications (ICET-98). The Sub-Rapporteurs Group will be chaired by Mr. Larry PRICE from IARU. There was a preliminary agreement to adopt modifications proposed by the United Nations to Doc. 2/010 as per their Doc. 2/047.
- 3.3 Liaison Statements in Documents 2/026, 2/028, 2/035, 2/036, 2/037, 2/038 were duly noted and any new Questions and/or Recommendations proposed would be followed up.
