A clear majority of RAs are ready to participate in an exchange • Key trend: a willingness **Total: 67 Countries** to reciprocate • A good opportunity to Europe 29% benefit both host and visiting countries • Of 70 regulatory authorities that replied to Americas 12% Asia Pac 25% the questionnaire, 67 Arab States 12% indicated interest

Countries are paired in tandem...



Seeking Training

- 56 regulatory authorities seeking training are willing to send their staff
- 58 regulatory authorities are willing to receive trainers/ advisors from overseas

Providing Training

- 52 regulatory authorities are willing to send staff overseas to provide advice and training
- 47 regulatory authorities indicated that they were prepared to receive visitors, to provide training on their premises

When receiving staff providing Training and advice ...

- 20 regulatory authorities indicated they are prepared to assume travel expenses
- 45 regulatory authorities indicated they will provide accommodation.

When sending staff to receive training and advice ...

- 38 regulatory authorities indicated that they would bear travel costs
- 45 indicated that they would bear accommodation costs.

When sending staff to provide training and advice ...


- 20 regulatory authorities indicated they are prepared to assume travel expenses
- 26 regulatory authorities indicated they will assume accommodation expenses


When receiving staff to provide training and advice ...

- 5 regulatory authorities are prepared to assume travel expenses
- 26 were prepared to assume accommodation expenses to receive staff from other regulatory authorities seeking training and advice.
