## **2. Summary of the TSR Meeting of 18th January 2008**

### **Approval of Agenda**

The agenda, contained in TSR Doc-018, was approved.

#### **2.1 Document Location**

#### **2.2 Review & approve previous TSR meeting report**

The report of the meetings of September 2007, contained in TSR Doc-017 was approved.

#### **2.3 Review Status of input documents and liaisons requiring co-ordination**

TSR co-ordinator informs the meeting 247 input documents which need attention to manage time plan properly with participants' support. In addition, co-ordinator gives attention to the participants the complexity of the meeting joining with three events together such as NGN-GSI, IPTV-GSI and IdM-GSI.

The meeting agreed to the TSR co-ordinator's request for presentation of the following input contributions, which bring fundamental subjects for the work scope of NGN-GSI.

- C-426 (India Proposal for specifying for Interoperability): This contribution proposes to study the Interoperability aspects.

During the TSR, it is recommended to discuss of this subject with SG11 and SG17, while Q7/13 invite to discuss this subject.

- C-514 (Nortel Networks, Canada): This contribution proposes to remove the release concept which is used to develop NGN related recommendations.

During the TSR, clarifications about the intention of the proposal and migration plan to removal of release concept have been requested. Contributor explains removal of complications which rose between the release plan and the different stage of each document being developed would be one of the efficient ways of progress. The meeting shares concerns about difficulties of release concept in the NGN development while some participants wish to remain this concept. The meeting agreed to handle this subject in Q1/13 on its overall coordination role.

The Meeting received and reviewed a liaison statement from Chairman of ISO/IEC JTC1 SC6.

- TD-286 (GEN/SG13, Proposal of a collaboration progress between ISO/IEC JTC 1/SC 6 and ITU-T SG 13)

The meeting reviewed this liaison with kind introduction by JTC1 SC6 Chairman and shared the proposed work items on USN based on NGN. Q2/13 and Q3/13 will review the liaison and properly reply to them.

Chairman of FG IPTV which finished at the last December 2007 kindly introduced the summary of the final results of FG IPTV with deliverables and special note was made to the IPTV vocabulary document which widely but fundamentally impacts to NGN works as in following TD.

- TD-314 (PLEN/SG13, FG-IPTV deliverable ~ IPTV vocabulary of terms): This TD contains terms and definition which used in IPTV deliverables.

The meeting thanks to the FG IPTV on their excellent work and agreed to ask Q11/13 will take care about this document in line with NGN vocabulary document.

#### **2.4 Review schedule of joint Rapporteurs Meetings**

Scheduled meeting time plan including the joint meetings are introduced produced by secretariat which produced another set of printed copy and the TSR co-ordinator drew attention to the meeting carefully look

at bulletin board to find proper meeting time and places because of increasing joint meetings especially joint with IPTV-GSI and IdM-GSI.

- Q6/13, Q2/19 and Q5/19: FMC and mobility management
- Q3/13, Q6/13, Q2/19 and Q5/19: Support of FMC and MM including MCFArch
