DRAFT WTDC-17 DECLARATION 1 of 3 *(revisions related to text of TDAG 2016)*

recognised that

a) telecommunications/ICTs are a key tools for the further implementation of the outcomes of World Summit on Information Society for the period after 2015, approved by the Resolution A/70/125 of the UN General Assembly (UNGA) and enabler for social and economic development; and consequently for accelerating the timely attainment of the Sustainable Development Goals and Targets set out in UNGA Resolution A/70/1 the **Transforming our world: the 2030 Agenda for Sustainable Development**;

g) despite all the progress made during past years, the digital divide still remains, and is compounded by disparities in access, use and skills between and within countries, in particular between ITU regions, individual countries, urban and rural areas, as well as in the availability of accessible and affordable telecommunications/ICTs, particularly for women, youth, children, indigenous people and persons with disabilities and specific needs;

DRAFT WTDC-17 DECLARATION 2 of 3 *(revisions related to text of TDAG 2016)*

therefore declares that

- 1 universally accessible and affordable telecommunications/ICTs are a fundamental contribution towards the achievement of the Sustainable Development Goals by 2030 and serve as a driving force behind the development of the national and global economy, and to build a global information society;
- 2 innovation is essential in ushering high-speed, high-quality telecommunication/ICT infrastructure and services;
- 8 building trust, confidence and security in the use of telecommunications/ICTs as well as ensuring the protection of personal data and privacy, requires further international cooperation and coordination between governments, relevant organizations, private companies and other stakeholders.

DRAFT WTDC-17 DECLARATION 3 of 3 *(revisions related to text of TDAG 2016)*

9 cooperation between developed and developing countries as well as among developing countries are encouraged as this paves way for technical cooperation, technological transfer, and joint research activities and also contributes to bridging the digital divide between countries;

13 ITU membership and other interested parties should cooperate in implementation of Connect 2020 global telecommunication/information and communication technology goals and targets.

Accordingly, we, the delegates to the World Telecommunication Development Conference (WTDC-17), declare our commitment to accelerate the expansion and use of telecommunication/ICT infrastructure, applications and services for building the information society and for the timely attainment of the **Sustainable Development Goals and Targets set out in UNGA Resolution A/70/1 the "Transforming our world: the 2030 Agenda for Sustainable Development".**

✓ Regional cooperation and coordination

To merge WTDC Resolution 17 (Implementation of regionally approved initiatives at the national, regional, interregional and global levels) and WTDC Resolution 32 (International and regional cooperation on regional initiatives)

GENERAL ISSUES CONCERNING REVISION OF RESOLUTION 1 1 of 3

Resolution 1 Rules of procedure of the ITU Telecommunication Development Sector

We are proposing:

- a) to bring references to the ITU Constitution and the ITU Convention in line with the precise wording of the basic documents of the Union;
- b) to provide missing definitions, missing procedures (for example a procedure for deletion of recommendations) and provisions clarifying the existing procedures;
- c) to introduce new Section 2 (*similar to the texts introduced into WTSA Resolution 1*) – “Documentation of ITU-D” that contains definitions of documents and methods for their adoption/approval and deletion;
- d) incorporate the relevant provisions of WTDC Resolution 31 – “Regional preparations for world telecommunication development conferences” into WTDC Resolution 1 and suppress WTDC Resolution 31;
- e) to revise the text of Section 2 (now Section 3) on using the mechanism of Working Parties and Section 15 (now Section 16) on using electronic access;
- f) to harmonize WTDC Resolution 1, in the extent practicable, with rules of procedure and working methods of other Sectors taking into account amendments introduced by RA-15 and WTSA-16 while respecting, at the same time, specificity of ITU-D;
- g) to apply the same numbering scheme as being used by other Sectors (linked to Section).

GENERAL ISSUES CONCERNING REVISION OF RESOLUTION 1 2 of 3

Resolution 1 Rules of procedure of the ITU Telecommunication Development Sector

We do not support introduction of Focus groups in ITU-D.

Taking into account the limited financial resources of ITU-D it would not be possible to provide:

- a) financial support for participation of developing countries in focus group meetings;
- b) translation of submitted input documents;
- c) interpretation during meetings of focus groups;

These factors would not allow effective participation of developing countries in meetings of focus groups. Moreover, the previous experience in ITU-D clearly indicated that many documents submitted to focus group meetings were also submitted for consideration by study groups and that leads to duplication of work and wasting limited resources.

Preliminary draft RCC/CIS Regional initiatives

1. Development of e-health to ensure healthy lives and promote well-being for all, at all ages;
2. Use of telecommunications/ICT to ensure inclusive, equitable, quality and safe education, including the enhancement of women's knowledge of ICTs and e-government;
3. Development and regulation of infocommunication infrastructure to make cities and human settlements inclusive, safe and resilient;
4. Monitoring of the ecological status and of the presence and rational use of natural resources;
5. Fostering innovative solutions and partnership for the implementation of Internet of Things technologies and their interaction in telecommunication networks, including 4G, IMT-2020 and next-generation networks, in the interests of sustainable development
