It is my great pleasure to invite your organization to the **Regional Forum for Europe on "Accessible Europe: ICT 4 ALL"** that will take place virtually from **23 to 25 March 2021**, and kindly encourage you to engage in a **series of activities** that are being launched in the lead-up to this event with the aim of advancing digital accessibility agenda. **Accessible Europe** is being jointly organized by the Telecommunication Development Bureau (BDT) of the International Telecommunication Union (ITU) and the European Commission (EC). The organisation of this event is supported by the Government of Portugal and is conducted as part of the Portuguese Presidency of the Council of the European Union.

Accessible Europe and all related activities are held within the framework of the Regional Initiative for Europe on Accessibility, affordability and skills development for all to ensure digital inclusion and sustainable development, adopted by the World Telecommunication Development Conference 2017. This regional initiative aims at bridging the digital divide and equipping all groups of society, including persons with disabilities and other groups of people with specific needs, to take advantage of ICTs, by enabling capacity building and sharing experience on how to design, develop and use accessible ICTs.

Information and Communication Technologies (ICTs) are of vital importance for people's empowerment and in promoting accessibility policies to make Europe region a more inclusive society. In this context, the Forum will focus on further promoting the development of ICT accessibility in countries and institutions through cooperation, programmes and projects development, and generate partnerships, and training.

ITU and EC have joined efforts to encourage Governments, Private Sector, Civil Society, Academia and other stakeholders to promote ICT accessibility in order to create fair and equal opportunities for all people and support a regional development agenda by treating ICT accessibility for people with specific needs and in particular persons with disabilities, as a cross-cutting development issue.

The organisers of the event are planning an effective integration of all stakeholders in the activities of the programme and request your participation and collaboration to further promote the following initiatives in your communities:

- ITU Event for Europe Towards Digitally Accessible Europe: This special event, which will take place virtually on 3 December 2020, 10.00-12.00 CET, is part of ITU's joint efforts with several partner organisations to promote digital accessibility in the European region as well as commemorate the beginning of Accessible Europe 2021. The event is being held in the context of the International Day of Persons with Disability. All stakeholders are invited to join and follow the event.    candidates will be announced on 19 February 2021 and Winners will be announced on 23 March 2021

  with Disabilities in Europe: A regional assessment was launched earlier this year targeting 46
  countries of the Europe region, aiming at providing all stakeholders with a holistic overview of the
  current implementation status of ICT accessibility laws, regulations, policies and strategies in the
