Subject: Announcement of the establishment of Task Group 1/9 on compatibility between different passive and active services

Introduction

The first meeting of the CPM06 recommended the establishment of Task Group (TG) 1/9 to deal with the compatibility between different passive and active services (WRC-07 Agenda items 1.20 and 1.21).

Radiocommunication Study Group 1 adopted a Decision [Doc. 1/10] on the establishment of TG 1/9 and nominated Mr. V. Meens (France) as Chairman and Mr. T. Sullivan (USA) as Vice-Chairman (see Annex 1).

The first meeting of the TG 1/9 will be held in Geneva from 19 to 23 April 2004. A draft agenda for the meeting is contained in Annex 2.

Working method

Task Group 1/9 will conduct its work in English. The Secretariat has established an e-mail reflector (<u>rtg1-9@itu.int</u>) to facilitate the exchange of information. Documents relevant to TG 1/9 will be made available to all participants on the ITU Web site:

The Secretariat cannot guarantee that documents received after the 7-day limit can be made available for the opening of the meeting and submissions received later than 12:00 hours (Geneva time) on the working day preceding the opening of the meeting cannot be accepted. Resolution ITU R 1-4 provides that contributions which are not available to participants at the opening of the meeting shall not be considered.

Visa requirements

Any such request must specify the name and functions of the individual(s) for whom the visa(s) is/are requested and be accompanied by a copy of the approved registration form approved for the ITU conference or meeting in question.

DECISION ITU-R [DOC. 1/10]

Preparation for WRC-07 Agenda items 1.20 and 1.21 concerning the protection of passive service bands from unwanted emissions

ITU-R Study Group 1,

considering

a) that ITU Council is expected to approve an agenda for WRC–07 that includes consideration and appropriate action with respect to the following items:

1.20 to consider the results of studies, and proposals for regulatory measures regarding the protection of the Earth exploration-satellite service (passive) from unwanted emissions of active services in accordance with Resolution 738 [COM4/14] (WRC-03);

1.21 to consider the results of studies regarding the compatibility between the radio astronomy service and the active space services in accordance with Resolution 740 [COM4/17] (WRC–03), in order to review and update, if appropriate, the Tables of threshold levels used for consultation that appear in the Annex to Resolution 739 [COM4/15] (WRC–03);

b) that in Resolution 738, WRC–03 *resolves*:

1 to invite ITU-R to continue or to initiate studies on the compatibility analyses between *EESS* (passive) and the corresponding active services as listed in the Table with a view to updating Recommendation ITU-R SM.1633 or developing additional Recommendations;

2 to invite ITU-R to further study the impact of implementing the values provided in considering f) and g) for unwanted emissions of fixed-service systems operating in Regions 2 and 3, taking into account that the impact on fixed-service systems in Region 1 has already been investigated;

3 to recommend that WRC-07 review the results of the studies identified in resolves 1 and 2 in order to consider regulatory measures, if appropriate, to ensure the protection of the EESS (passive) operating in the bands listed in the Table from unwanted emissions of active services operating in the corresponding bands while taking into account the impact on all concerned services of implementing or not implementing such measures;

c) that in Resolution 740, WRC–03 *resolves*:

1 to invite *ITU-R* to study the compatibility between the RAS and the corresponding active space services as listed in the Table only, with a view to updating or developing *ITU-R* Recommendations, if appropriate;

2 that WRC-07 should consider the results of the studies as identified in resolves 1, in order to review and update, if appropriate, the Tables of threshold levels for consultation in the Annex to Resolution 739 [COM4/15] (WRC-03);

d) that CPM06–1 decided that studies in support of these agenda items would be conducted by a Task Group to be established by Study Group 1,

decides

1 that Task Group 1/9 is established in order to urgently address WRC–07 Agenda items 1.20 and 1.21;

2 that, in support of Agenda item 1.20, the Task Group will study compatibility between the Earth exploration-satellite (passive) service and unwanted emissions from active services in the frequency bands specified in the Table in Resolution 738;

3 that, in support of Agenda item 1.21, the Task Group will consider the table of threshold levels for consultation that appear in the annex to Resolution 739, with a view to updating them, as appropriate, in accordance with Resolution 740;

4 that the Task Group will update or develop ITU–R Recommendations, as appropriate, based on the studies described in *decides* 2 and 3;

5 that the Chairman and Vice-Chairman of Task Group 1/9 are Mr. Vincent MEENS and Mr. Thomas SULLIVAN, respectively:
