Subject: Proposed approval of 1 draft revised Recommendation and 1 draft new Recommendation adopted by Radiocommunication Study Groups 4 and 9

At the joint meeting of ITU-R Study Groups 4 (Fixed-satellite service) and 9 (Fixed service) held on 12 October 2004, the Study Groups adopted the texts of 1 draft revised Recommendation and 1 draft new Recommendation, and agreed to apply the procedure of Resolution ITU-R 1-4 (see § 10.4.5) for approval of Recommendations by consultation. The titles and summaries of these Recommendations are given in Annex 1. In connection with the draft revision to Recommendation ITU-R SF.1650, those Member States having a reservation or objection to the current version are invited to consider the possibility of withdrawing the reservation or objection from the revised version. In such cases, the Member State concerned is requested to indicate its decision when responding to this Administrative Circular.

Having regard to the provisions of § 10.4.5.2 of Resolution ITU-R 1-4, I should be grateful if you would inform the Secretariat (<u>brsgd@itu.int</u>) by 24 February 2005, whether your Administration approves or does not approve these draft Recommendations.

A Member State who indicates that a draft Recommendation should not be approved is requested to advise the reason and indicate possible changes in order to facilitate further consideration by the Study Group during the study period (§ 10.4.5.5 of Resolution ITU-R 1-4).

After the above-mentioned deadline, I will notify the results of this consultation by administrative circular and make arrangements for the approved Recommendations to be published in accordance with § 10.4.7 of Resolution ITU-R 1-4.

Draft new Recommendation ITU-R SF.[Doc. 4/4-9/2]

Doc. 4-9/BL/1

Sharing between point-to-point and point-to-multipoint FS and transmitting earth stations of GSO and non-GSO FSS systems in the 27.5-29.5 GHz band

This draft new Recommendation examines sharing as described in the title. The Annex provides various methodologies of interference analysis to support the *recommends* that administrations avoid the deployment of FS receiver stations and large numbers of FSS transmitting earth stations with overlapping frequencies within the band 27.5-29.5 GHz in the same geographical area

<u>Draft revision of Recommendation ITU-R SF.1650 (Doc. 4/12-9/6)</u>

Doc. 4-9/BL/2

The minimum distance from the baseline beyond which in-motion earth stations located on board vessels would not cause unacceptable interference to the terrestrial service in the bands 5 925-6 425 MHz and 14-14.5 GHz

The editorial draft revisions are intended to align the references to the definition of the measuring point in Recommendation ITU-R SF.1650 with the wording used in Resolution 902 (WRC-03). These amendments may permit some administrations to withdraw their reservations or objections to this Recommendation and to Recommendations ITU-R SF.1648 and ITU-R SF.1649.
