Subject:Radiocommunication Study Group 1

 Proposed approval of 1 draft new Recommendation and 1 draft revised Recommendation

At the meeting of ITU-R Study Group 1 (Spectrum management) held on 16 and 17 October 2006, the Study Group decided to seek adoption of 1 draft new Recommendation and 1 draft revised Recommendation by correspondence, according to § 10.2.3 of Resolution ITU-R 1-4.

As stated in Circular letter 1/LCCE/78, dated 10 November 2006, the consultation period for the Recommendation ended on 10 January 2007.

The Recommendations have now been adopted by Study Group 1 and the approval procedure of Resolution ITU-R 1-4 § 10.4.5 is to be applied, noting the interim procedures recommended by the RAG at its meeting in November 2004^{*}. The titles and summaries of the Recommendations are given in Annex 1.

Having regard to the provisions of § 10.4.5.2 of Resolution ITU-R 1-4, you are requested to inform the Secretariat (<u>brsgd@itu.int</u>) by <u>23 April 2007</u> whether your Administration approves or does not approve these draft Recommendations.

A Member State who indicates that a draft Recommendation should not be approved is requested to advise the Secretariat of the reason and to indicate possible changes in order to facilitate further consideration by the Study Group during the study period (§ 10.4.5.5 of Resolution ITU-R 1-4).

After the above-mentioned deadline, the results of this consultation will be notified in an Administrative Circular and arrangements made for the approved Recommendations to be published in accordance with § 10.4.7 of Resolution ITU-R 1-4.

Titles and summaries of the draft Recommendations adopted by Radiocommunication Study Group 1

Draft revision of Recommendation ITU-R SM.1056 (Doc. 1/118(Rev.1))

Doc. 1/BL/17

Limitation of radiation from industrial, scientific and medical (ISM) equipment

This revision is to update the noting information that is not consistent with the recent work of International Special Committee on Radio Interference (CISPR) regarding RF lighting devices. Considering part and Annex 1 of this recommendation are updated and new recognizing part is added according to the latest version of Radio Regulation (**RR**) and relevant ITU-R Resolutions.

Standard data exchange format for frequency band registrations and measurements at monitoring stations

A general data exchange format should be as simple as possible, no "packing material" of any kind should be used around the data. The file format should also have a long lifespan. This is the reason that plain ASCII is chosen for the file format.

An effective merge or comparing of data requires that data to be generated in such a way that essential elements of the data have a common base. Therefore the Recommendation also contains some items to be agreed on before starting a measurement campaign.
