Subject: Radiocommunication Study Group 7

Proposed approval of 1 draft revised Recommendation

At the meeting of ITU-R Study Group 7 (Science services) held on 4 and 12 October 2010, the Study Group decided to seek adoption of 1 draft revised Recommendation by correspondence, according to § 10.2.3 of Resolution ITU-R 1-5.

As stated in Circular Letter 7/LCCE/54, dated 10 November 2010, the consultation period for the Recommendation ended on 10 January 2011.

The Recommendation has now been adopted by Study Group 7 and the approval procedure of Resolution ITU-R 1-5 § 10.4.5 is to be applied. The title and summary of the Recommendation are given in the Annex.

Having regard to the provisions of § 10.4.5.2 of Resolution ITU-R 1-5, you are requested to inform the Secretariat (brsgd@itu.int) by 21 April 2011 whether your Administration approves or does not approve the draft Recommendation.

A Member State who indicates that the draft Recommendation should not be approved is requested to advise the Secretariat of the reason and to indicate possible changes in order to facilitate further consideration by the Study Group during the study period (§ 10.4.5.5 of Resolution ITU-R 1-5).

After the above-mentioned deadline, the results of this consultation will be notified in an Administrative Circular and arrangements made for the approved Recommendation to be published in accordance with § 10.4.7 of Resolution ITU-R 1-5.
