**Subject: Radiocommunication Study Group 1 (Spectrum management)**  
– **Proposed approval of 1 draft new Recommendation**

At the meeting of ITU-R Study Group 1 held on 2 June 2011, the Study Group decided to seek adoption of 1 draft new Recommendation by correspondence, according to § 10.2.3 of Resolution ITU-R 1-5.

As stated in Circular Letter 1/LCCE/91, dated 17 June 2011, the consultation period for the Recommendation ended on 17 August 2011.

The Recommendation has now been adopted by Study Group 1 and the approval procedure of Resolution ITU-R 1-5 § 10.4.5 is to be applied. The title and summary of the Recommendation are given in the Annex.

Having regard to the provisions of § 10.4.5.2 of Resolution ITU-R 1-5, you are requested to inform the Secretariat ([brsgd@itu.int](mailto:brsgd@itu.int)) by 26 November 2011 whether your Administration approves or does not approve the draft Recommendation.

A Member State who indicates that the draft Recommendation should not be approved is requested to advise the Secretariat of the reason and to indicate possible changes in order to facilitate further consideration by the Study Group during the study period (§ 10.4.5.5 of Resolution ITU-R 1-5).

After the above-mentioned deadline, the results of this consultation will be notified in an Administrative Circular and arrangements made for the approved Recommendation to be published in accordance with § 10.4.7 of Resolution ITU-R 1-5.

Any ITU member organization aware of a patent held by itself or others which may fully or partly cover elements of the draft Recommendation(s) mentioned in this letter is requested to disclose such information to the Secretariat as soon as possible.
