Subject: Application of **Nos.11.44/11.44.1** of the Radio Regulations to satellite networks with the 9-year expiry date for notification between 1st January and 30 June 2007

Dear Sir,

- 1. The Radiocommunication Bureau hereby draws the attention of all administrations to the application of provisions of **Nos. 11.44** and **11.44.1** of the Radio Regulations to satellite networks with APIs received before 22 November 1997, whose 9-year period for submission of notification expires between 1st January and 30 June 2007.
- 2. These provisions stipulate that the assignments included in a request for coordination shall no longer be taken into account by the Bureau or administrations unless, by the end of the nine-year regulatory period as from the date of publication of the relevant advance publication information (API), for APIs received before 22 November 1997:
 - the assignments in question have been brought into use, and
 - the complete first notice for recording of these assignments under No. 11.15 has been received by the Bureau.
- 3. In this context, the Bureau has prepared two lists of networks with an indication of their respective API date of publication and respective nine-year regulatory period expiry date, which falls between 1st January and 30 June 2007, as follows:
- 3.1. Annex 1 contains the list of networks for which no notification information seems to have yet been received by the Bureau (see also paragraph 4 below);
- 3.2 Annex 2 contains the list of networks for which notification information, <u>having been received</u>:
 - a) is under examination, or
 - b) was returned to the administration as the result of an unfavourable finding, or
 - was recorded in the MIFR as the result of a favourable finding.
 (See also paragraph 5 below)

Please note that satellite networks, for which the 7-year expiry date for notification falls between 1st January and 30 June 2007 (i.e. with API received between 1st January and 30 June 2000), were dealt with in Circular Telegram CTITU A104 sent on 26 June 2006.

- 4. The Bureau requests your Administration to kindly verify the attached lists and submit the notification information under No. 11.15 before the indicated expiry of the 9-year period, either with all the required agreements obtained (No. 11.32), or with a <u>statement that some coordination could not be successfully completed</u> and with a request to apply the provisions of Nos. 11.32A, 11.35 or 11.41, as appropriate, with respect to certain missing agreements. It should be noted that, for cases falling under *resolves 2* of Resolution 49 (Rev.WRC-03), receivable will be only notification of assignments covered by due diligence information already received by the Bureau.
- 5. With respect to the notification information received and considered under a), b) or c) of paragraph 3.2) above, no action may be needed. Nevertheless, similar or additional notification information may still be submitted before the indicated expiry of the 9-year period, in order to cover all the frequency assignments included in the request(s) for coordination or for advance publication information, according to the case.
- 6. Your Administration is also kindly requested to check further whether any of its networks, not listed in the Annexes, also fall into the above category and, if so, to submit the notification information as mentioned in paragraphs 4 and 5 above for the corresponding assignments still at the coordination stage or published as an advance publication information, according to the case, and for which the nine-year regulatory period will expire between 1st January and 30 June 2007.
- 7. Please note that this communication is to be considered as the Bureau's advance notice referred to in Nos. 11.44/11.44.1.
- 8. The Bureau trusts that your Administration will provide the required information as indicated above. In the event that the assignments are not brought into use and the notification information is not received by the Bureau within the relevant period, the Bureau will initiate the cancellation of the relevant assignments as foreseen by Nos. 11.44/11.44.1, according to the case.
