# Adama Samassékou President of the WSIS Preparatory Committee

# REPORT ON THE PREPAR ATORY PROCESS FROM PREPCOM-2 TO PREPCOM-3

#### I Introduction

### 1 Organization of the World Summit on the Information Society (WSIS)

United Nations Resolution 56/183 on the organization of WSIS, adopted by the General Assembly on 21 December 2001, recommends that an open-ended intergovernmental preparatory committee be set up to prepare for WSIS. At the first meeting of the Preparatory Committee, which took place from 1 to 5 July 2002<sup>1</sup>, Mr Adama Samassékou, former Minister of Education of Mali, was elected as President. Also elected were 16 Vice-Presidents (three Vice-Presidents for each UN region, and two *ex-officio* Vice-Presidents for each of the two host countries (Switzerland and Tunisia)). These officials constitute the Bureau of PrepCom<sup>2</sup>.

The second meeting of the Preparatory Committee took place from 17 to 28 February 2003 in Geneva.

#### II Second meeting of the Preparatory Committee

#### 2 Decisions on intersessional work between PrepCom-2 and PrepCom-3

Three days were devoted to contributions from visionaries at the highest level and thematic round tables. The PrepCom-2 participants then examined, within Subcommittee 2 on content, the draft Declaration of Principles and the draft Action Plan for WSIS. Subcommittee 2 set up a working group under the chairmanship of South Africa.

At the end of the meeting and with the aim of ensuring continuity in the work on content, PrepCom-2 requested the Chairman of the working group of Subcommittee 2 to prepare, by 21 March 2003, a consolidation of the written contributions received at 28 February 2003, and draw up *basic working documents* for the future negotiations.

PrepCom-2 mandated the President of PrepCom to oversee the intersessional work and, *inter alia*, to bring together a *formal intergovernmental drafting group for a five-day meeting in July 2003*, so as to advance negotiations on the content.

PrepCom-2 further decided to set up an *intersessional mechanism* to refine further the documents for the meeting of the aforementioned drafting group.

Finally, PrepCom-2 mandated the WSIS Executive Secretariat to *prepare a reference document* containing written contributions from participants, for publication on the WSIS website.

## 3 Implementation

Under the supervision of the President of PrepCom acting in liaison with the PrepCom Bureau, the *basic working documents* were drawn up and posted on the WSIS website on 21 March 2003, together with the *Reference Document* setting out all contributions received by 31 May 2003, namely from governments, intergovernmental organizations, the private sector and civil society. The first part of the reference document was published on the website on 12 June 2003 and the whole document (376 pages) at the beginning of July 2003.

Through the good offices of the Director-General of UNESCO, a *meeting of the formal intergovernmental drafting group* was organized from 15 to 18 July 2003 at UNESCO headquarters in Paris. The dates were set on the basis of UNESCO availabilities and to avoid a clash with the APT meeting on information society initiatives organized in Bangalore from 21 to 25 July 2003.

PrepCom-2's decision to put in place an *intersessional mechanism* gave rise to lengthy and arduous discussion within the PrepCom Bureau, which was torn between a desire to adhere to the letter of the decision and the need to reflect the spirit of the decision in order to make significant progress in work on refining the documents during the intersessional period.

After several Bureau meetings and following bilateral consultations conducted by the PrepCom President with each member country of the Bureau and each regional group, the members of the Bureau decided to follow PrepCom-2's decision strictly to the letter. They therefore mandated the President of PrepCom, with assistance of the WSIS Executive Secretariat and in collaboration with the Chairman of the Working Group, merely to refine the documents without altering the content, so as not to prejudge the negotiations in July.

This refining work<sup>3</sup> was submitted on 5 June 2003 to the members of the Bureau, who endorsed it. The refined documents were posted on the WSIS website on 5 June 2003.

In view of the enormous quantity of written contributions on the draft Declaration and draft Action Plan received by the Executive Secretariat up to the end of May, the President of PrepCom and the members of the Bureau both considered that it was necessary to carry out some consolidation work in order to make the basic working documents easier to use at the July intersessional meeting. Under a mandate from the Bureau, the President of PrepCom therefore prepared, with the assistance of the Executive Secretariat, *working documents* for the intersessional meeting, in which all the contributions from governments were incorporated. These documents were posted on the WSIS website in mid-June.

Again with the same aim of preparing the July 2003 meeting effectively, the members of the Bureau also agreed to the proposal by the President of PrepCom to draw up, with the assistance of the WSIS Executive Secretariat, a *reader's guide*, as suggested by a member of the Bureau, for use by participants as a handy tool for rapidly identifying points of convergence and divergence and new points in the contributions on the draft Declaration and draft Action Plan. This reader's guide was drawn up, taking into account also the contributions from observers, and published on the WSIS website at the beginning of July 2003.

## 4 PrepCom Bureau

Since February 2003 the President has convened 12 meetings of the Bureau, three of them in Paris. The meetings served to analyse the decisions of PrepCom-2 and agree on how to proceed during the intersessional period up to PrepCom-3.

## 5 Dissemination of information to all WSIS participants

Throughout this period, the President has carried out various consultations with representatives of the private sector, civil society and intergovernmental organizations in order to keep them informed of the implementation of PrepCom-2's decisions, assuring them that their inputs are being taken into account in the documents. Furthermore, the regional group coordinators within the Bureau have also kept the representatives of countries of their region regularly informed on the WSIS preparatory process.

In addition, a special information meeting open to any interested party was organized on 23 June 2003 in Geneva, to provide information on the status of intersessional work and the issues to be addressed at the July meeting.

## **III** Intersessional meeting

#### 6 Organization and work

As indicated in § 3 above and pursuant to a decision of the second meeting of the Preparatory Committee, the President of the PrepCom convened a formal open-ended intergovernmental drafting group, held at UNESCO in Paris from 15 to 18 July 2003, with the mandate to advance negotiations on the draft Declaration and Action Plan. The drafting group meeting was attended by 750 delegates.

The opening session of the meeting, at the proposal of the PrepCom Bureau, elected Lyndall Shope-Mafole (Republic of South Africa) by acclamation as its Chairman. The agenda was adopted. The session was addressed by the Director-General of UNESCO, the Secretary-General of ITU and the President of the PrepCom, and by the Minister in charge of Research and New Technologies of France.

The work began with a discussion of the draft Declaration of Principles and the draft Action Plan, as refined since PrepCom-2. To advance the work, the Chairman established the following small groups to consider difficult issues: Right to Communicate, Internet Management, Good Governance and Network Security.

The meeting was open to observers. At the beginning of the deliberations, two hours were set aside for observers to express their priorities in relation to the basic documents; on subsequent days, observers were given the floor for one hour at the beginning of the meeting. The following observers addressed the meeting:

- Representatives of intergovernmental organizations: CERN, Council of Europe, ITSO, ITU, OECD, UNCTAD, UNESCO, UN Habitat, UN ICT Task Force, UNECA, UNITAR and WMO;
- Representatives of civil society: African Women's Development and Communication Network - FEMNET, AMARC, ANAIS Network, CSDPTT, Daisy Consortium, ENSTA, European Broadcasting Union, LANETA, IFUW, International Association for Media and Communication Research, International Federation of Library Associations and Institutions - IFLA, ISIS International, Molecular Diversity Preservation International, Rights & Democracy, Taking IT Global, University of Aarhus and Ville de Lyon - France;
- Representatives of the private sector: Alcatel, AT&T (ICC), Brazilian Chamber of Commerce (ICC), France Telecom, French Publishers Association (ICC), ICC, Masreya (ICC), Nokia and TAG International.

The meeting reviewed and revised the draft Declaration of Principles<sup>4</sup>, which will now be submitted for final negotiation at PrepCom-3 in Geneva. The meeting also exchanged views on the draft of the Action Plan<sup>5</sup>.

#### 7 Further action

At its meeting on 18 July, the PrepCom Bureau decided to send the revised text of the draft Declaration direct to PrepCom-3, without amendment, and mandated the Chairman of the Drafting Group to carry out a further revision of the Action Plan, on the basis of the comments formulated at the intersessional meeting, during the intersessional period until PrepCom-3, with the assistance of the Executive Secretariat and under the supervision of the President of PrepCom. The Bureau also decided that the regional coordinators within the Bureau should be associated with this work, which would be examined at the Bureau's meeting on 22 August 2003. This decision of the Bureau was announced at the closure of the Paris meeting and distributed as a Note by the President of PrepCom<sup>6</sup>.

This task was completed within the set time-frame and the revised text of the draft Action Plan was published on the WSIS website on 26 August 2003<sup>7</sup>.

## IV Activities undertaken to enhance the visibility of WSIS

## 8 Participation in international conferences
