I INTRODUCTION

- In its Resolution 56/183 of 21 December 2001, the General Assembly of the United Nations welcomed the resolution of the Council of the International Telecommunication Union (ITU) endorsing the proposal put forward by the ITU Secretary-General for the holding of the World Summit on the Information Society (WSIS). The General Assembly also invited the ITU to assume the leading role in organizing the Summit and its preparatory process, in cooperation with other interested organizations and partners.
- The General Assembly Resolution further recommended that the preparations for the Summit take place through an open-ended intergovernmental preparatory committee that would define the agenda of the Summit, finalize both the draft Declaration of Principles and the draft Plan of Action, and decide on the modalities for the participation of other stakeholders in the Summit.

II ORGANIZATION

A Opening and duration of the meeting

- The Preparatory Committee for the World Summit on the Information Society held its third session from 15 to 26 September 2003 in Geneva. The Committee held four Plenary Meetings and 12 Subcommittee meetings.
- Mr Adama Samassékou, President of the Preparatory Committee, opened the first Plenary Meeting. Opening addresses were made by Mr Yoshio Utsumi, Secretary-General of the ITU and Chairman of the High-Level Summit Organizing Committee (HLSOC); by Mr Moritz Leuenberger, Federal Councillor and Head of the Federal Department of Environment, Transport, Energy and Communications, who spoke on behalf of the Swiss Government; and by Mr Nitin Desai, Special Adviser to the United Nations Secretary-General for the WSIS.

III DRAFT RULES OF PROCEDURE OF THE WSIS

- At its second plenary meeting on 22 September 2003, the Preparatory Committee, based on the Report of the Chairman of Subcommittee 1, adopted the Draft Rules of Procedure of the WSIS (WSIS/PC-3/DOC/11). This document appears as Annex 1 to this Interim Report.
- Following the adoption of the Draft Rules of Procedure of the WSIS, the Spanish delegation took the floor and requested that the following statement be included in the report:

"Once again Spain re-affirms its renowned commitment to the progress of the World Summit on the Information Society and supports the adoption by unanimity of its Rules of Procedure.

Moreover, Spain is pleased to note that these revised Rules will allow broad participation by NGOs, the civil society and business entities, an important aspect of the reform process undertaken by the United Nations, with the support of the Spanish government, of all related fora.

In this context, the Government of Spain wishes to make known that it understands these Rules of Procedure which were approved now in a way that they will in no case violate the letter or the spirit of article 149 of the Spanish Constitution."

IV DRAFTWSIS DECLARATION OF PRINCIPLES, DRAFT WSIS PLAN OF ACTION AND REPORT OF SUBCOMMITTEE 2

- Subcommittee 2 met xx times during PrepCom-3 to review the Draft Declaration of Principles (WSIS/PC-3/DOC/2) and the Draft Plan of Action (WSIS/PC-3/DOC/3). It also established a Working Group, with Ms Lyndall Shope-Mafole (South Africa) as Chairperson. The draft text of the Declaration of Principles was considered by a special meeting of the Heads of Delegation.
- In order to progress work on the two documents, ad hoc groups were set up on specific topics under the guidance of different countries.
- 27 It was agreed that observers could attend the discussions in the Plenary and Working Group Meetings and would be invited by the Chairperson to make brief statements. Observers were also invited to make brief statements at the start of each ad hoc group meeting.

- A revised Draft Declaration of Principles (WSIS/PC-3/DT-1) was issued on Friday 19 September and a Chairman's Draft Plan of Action (WSIS/PC-3/DT-2) was issued on Sunday 21 September. Subsequent revisions of both documents were issued as follows:
 - Draft Declaration of Principles: WSIS/PC-3/DT-/1 (Rev. 1) on 24 September 2003, (Rev. 2) and (Rev. 2A) on 25 September 2003 and (Rev. 2B) on 26 September 2003. In the evening of 26 September 2003, an Annex to (Rev. 2B) was issued.
 - Draft Plan of Action: WSIS/PC-3/DT-/2 (Rev. 1) on 24 September 2003. The subsequent version was issued as Addendum 2 to the Report of the Chair of Subcommittee-2. In the evening of 26 September 2003, a Corrigendum 1 to Addendum 2 was issued.
- At its third Plenary meeting on 26 September 2003, the Preparatory Committee heard the report of the Chair of Subcommittee-2 (WSIS/PC-3/DOC/10) (Annex 2 to this Interim Report), considered the revised version of the Draft Declaration of Principles (WSIS/PC-3/DT-1 (Rev.2B) with its Annex dated 26 September 2003) and the revised version of the Draft Plan of Action (WSIS/PC-3/DOC/10 Addendum 2, with Corrigendum 1 dated 26 September 2003) and decided that both documents should be considered as the basis for future negotiations. The two documents appear as Addendum 1 and Addendum 2 to Annex 2 in this Interim Report.

V ORGANIZATION OF WORK OF THE GENEVA PHASE OF THE SUMMIT

The draft agenda and the proposed format for the Geneva phase of the WSIS, as approved by the fourth Plenary meeting on 26 September 2003, are contained in Documents WSIS/PC-DOC/9 and WSIS/PC-3/DOC/8 (Rev.2), respectively. Those documents are attached to this report as Annexes 3 and 4. Paragraph 5 of WSIS/PC-3/8 (Rev.2) and paragraph 10 of its Annex 2 were the object of reservations by delegations from Australia, the United States of America and Israel. Furthermore, the Secretariat was requested by those delegations to verify with the UN Secretariat how these two paragraphs conform to UN legal and protocol practice.

VI ARRANGEMENTS FOR THE TUNIS PHASE OF THE SUMMIT

The President of PrepCom briefly summarized the situation with regard to the arrangements for the Tunis phase of the Summit, which have been discussed by the Bureau on a number of occasions. The Bureau has taken note of the report to PrepCom-2, which recommends that the Tunis phase of the Summit focus on the adoption of a digital solidarity charter and an agenda for regional action plans. In light of documents submitted by Tunisia and a proposal from the ITU Secretary-General, the Bureau requested more time to study the question and present its conclusions when PrepCom-3 resumes its work in November.

VII ADOPTION OF THE DRAFT INTERIM REPORT OF THE THIRD MEETING OF THE PREPARATORY COMMITTEE

The draft Interim Report of the Third Meeting of the Preparatory Committee was adopted during the Plenary Meeting on Friday, 26 September 2003. The Rapporteur was entrusted with the task of finalizing the Interim Report, with the assistance of the Executive Secretariat.

VIII SUSPENSION OF THE THIRD MEETING OF THE PREPARATORY COMMITTEE

- PrepCom-3 decided to suspend its meeting and to reconvene in Geneva from 10 to 14 November 2003 (subject to the availability of resources) and from 7 to 9 December 2003.
- 34 PrepCom-3 requested that:
 - 1) The President supervise informal consultations to facilitate the negotiations at the reconvened sessions;
 - 2) On the basis of the discussions at PrepCom-3, as well as his consultations, the President prepare a non-paper on the Declaration;
 - 3) The reconvened PrepCom-3 use document WSIS PC-3/DT-/1 (Rev. 2B) (Declaration of Principles) and WSIS/PC-3/DOC/10 (Rev. 1) (Add. 2) DT-2 (Rev.1) (Plan of Action) as its basis for negotiation. It may also consider the President's non-paper.
