Subject to technical capacity, the secretariat may be in a position to allocate an extra "speaker" slot.

An informal meeting will be held on 7 June 2021, followed by an information session on the New Headquarters Premises Project. Registration to C21\VCC-1 will provide access to both the informal meeting and the information session.
