## **STATEMENT**

### **In support of the candidacy of Mr Hassan TALIB, of the Kingdom of Morocco, for the post of member of the Radio Regulations Board (RRB) for the Africa region (D)**

Today, radiocommunication systems, technologies and applications serve, in all their diversity (mobile networks, broadcasting, satellite services, etc.), as an essential basis for the implementation of telecommunication services in our lives. Consequently, the radio-frequency spectrum is the most widely used means of contributing to the development and accessibility of these services, particularly in remote areas. In addition, radio frequencies play a crucial role in ensuring safety of human life in maritime and aeronautical settings or in the event of natural disasters and emergencies. This can only be achieved, however, through sustained regulation of frequencies at both international and national levels.

This trend further strengthens the role of radiocommunication bodies, in particular, the International Telecommunication Union (ITU) and its Radiocommunication Bureau (BR), and the interest of States, operators and manufacturers in the radio-frequency spectrum.

The Kingdom of Morocco has always attached great importance to the work of ITU, as demonstrated by its active participation in the different meetings and conferences of the Union and its support for the Union's various bodies.

Mr Hassan TALIB, elected member of RRB at the Plenipotentiary Conference 2018, has participated in all RRB meetings and greatly contributed to its work since 2019. He has been fastidious in performing his duties in the interests of all Member States, impartially and transparently, in accordance with the provisions of the ITU Constitution, Convention and Radio Regulations and in compliance with the decisions of world radiocommunication conferences (WRCs).
