Subject: **Informal consultation on the Council improvement**

Dear Sir/Madam,

I would like to thank you again for your participation in the informal virtual meeting with councillors held on 13 February 2023.

As a follow-up to this meeting, I am pleased to set out the following suggestions that I hope would help to further strengthen the effectiveness of the preparations to and deliberations of the Council:

1. The Secretariat recommends shortening the agenda of Council 2023 and ensuring that is focused on strategic items. An advanced draft agenda is available in the [Annex](#) of this letter for your comments and suggestions.

The draft agenda will be formally sent early April to all Member States, together with the invitation letter to the 2023 Session of the Council, calling for all Member States to propose any item by 16 May as per Rule 4.3 of the Rules of Procedures of Council.

2. The Secretariat suggests enhancing the preparatory process through a series of thematic virtual briefings for Council Member States.

The following dates have been reserved for these briefings: **19 April; 9 May and 22 June**.

These briefings will be held from **13:00 to 14:00 (Geneva Time)**. They will be conducted in English only. Registration is required and is available here:

The proposed topics for the thematic virtual briefings are the following: management of the Council Working Groups and Expert Groups, budget 2024-2025 and implementation of budget 2023, people strategy, digital transformation strategy, regional presence and initiatives, ITU new headquarters project, ITU business continuity, resource mobilization strategy, and preparation for the Council session.

Slides and information shared during the briefing will be made available under TIES protection, on the Council website.

The first thematic virtual briefing on 19 April will focus on the budget and the management of the Council Working groups and Expert Groups.

3. It is proposed to improve the format of Council documents. A revamped document template will help authors to highlight the linkage between their proposal, the strategic plan and possible financial implications.

To improve time management during the session and save time for effective debate, the Secretariat proposes that only selected documents, which will be identified at the later stage in the preparation, be presented. The other documents will be noted and/or adopted as a package. Council Member States will, of course, have the possibility to request the inclusion of specific documents to the list of documents to be presented, when proposing items for the inclusion into the Council's agenda as per the process set out in point 1 above.

It is also advised to limit the length of the annual report on the implementation of the strategic plan to 20 pages. The main report will focus on results and impact. All relevant data will be available as an online dashboard. An annex presenting the implementation of all relevant Plenipotentiary Resolutions will be published online with the view of limiting the number of stand-alone reports by Resolution.

Finally, in line with Annex 2 to Decision 5, it is proposed, as a matter of principle, to limit the length of input documents and contributions to four pages.

4. The Secretariat proposes to organize a high-level segment on the first day of Council on **“Building a fit for purpose ITU”**. It will be an opportunity for high-level delegates to share their views on the strategic direction of the ITU, on the basis of the state of the Union address delivered by the Secretary General, and the annual report on the implementation of the strategic plan.
5. Finally, it is suggested to organize a retreat with Councilors on Monday, 10 July. Further details will be provided to you in due course.

I am looking forward to engaging with you at the next thematic virtual briefing on 19 April.
