Subject: Organization of the 2023 session of the Council, 11-21 July 2023

Dear Councillor,

In accordance with Rule 1 of the Rules of Procedure of the Council, I have the pleasure to inform you that the 2023 session of the Council will be held physically at ITU headquarters from **Tuesday**, **11 July to Friday**, **21 July 2023**, preceded by a **Retreat** for Councillors on **Monday**, **10 July 2023**. A **High-Level Segment** will be organized on **Tuesday**, **11 July 2023**.

The overall theme of the Retreat and High-Level Segment will be "Creating a fit for the future ITU" and will draw on the key themes and priorities as identified by the ITU Plenipotentiary Conference 2022.

An invitation to Councillors, including details of the Retreat, will be provided separately. An invitation to Ministers of Council Member States to speak at the High-Level Segment and join the Retreat will also be sent in due course.

Preliminary draft agenda

Further to circular letter <u>DM-23/1003</u> sent on 17 March 2023 and after the first virtual thematic briefing held on 19 April 2023, we are pleased to present in the <u>Annex</u> to this letter an updated draft agenda of the Council-23 session.

To improve time management during the session and save time for effective debate, the secretariat proposes, as in the Annex, that selected documents be noted/approved as a package, without discussion being understood that all Member States retain the right to request that a specific document be discussed.

A draft time management plan is under preparation and will be sent to you in due course.

As per Council rule of procedure 4.3, Member States of the Union shall communicate to the Secretary-General at least eight (8) weeks before the opening of the session (**before 16 May 2023**), any further item they would like to propose.

Registration

Registration for the 2023 session of the Council will be carried out **exclusively online** at the following webpage: <u>https://www.itu.int/en/council/Pages/Registration.aspx</u>.

In line with ITU gender equality and mainstreaming policy and Resolution 198 (Rev. Bucharest, 2022) on empowerment of youth through telecommunication/information and communication technology, the aim is to organize an inclusive and gender-responsive Council. With that objective in mind, I would like to invite you to support and encourage the participation of women and young people in your delegation. More information on initiatives on gender-responsive Council and youth participation will be provided in due course on the Council-23 website (https://www.itu.int/en/council/).

Information related to badge collection will be made available in the e-confirmation of registration as well as on the Council website.

Documentation

In accordance with Annex 2 to Decision 5 (Rev. Bucharest, 2022), paragraph 10, and in order to reduce cost of documentation, Council documents will be made available <u>exclusively online</u> on the website at <u>https://www.itu.int/en/council/</u>. No paper copies of documents will be distributed before or during the 2023 Session of the Council.

An ITU C23 Sync Application will facilitate the download of C23 documents from the ITU server to your local drive. This application will be available on the Council website and is configured to synchronize the latest published documents. If you wish to be notified by e-mail when new or updated Council documents are posted, kindly update your TIES access at <u>https://www.itu.int/en/ties-services/</u>.

Contributions to the Council should be submitted as soon as possible to <u>contributions@itu.int</u>. In accordance with Council Decision 556, all contributions should be submitted <u>no later than 14 calendar days</u> before the opening of the meeting, i.e. **27 June 2023.** ITU secretariat documents calling for a decision of the Council will be posted on the relevant page of the website no later than 30 calendar days before the opening of the Council session. Member States will be invited to send their contributions to the meeting by using the <u>template</u> available on the Council-23 website.

As per the <u>ITU information/document access policy</u>, Council input documents will be publicly accessible, unless otherwise requested by the submitter(s) of the document.

In accordance with Council Decision 495, should a Member State of the Council consider that an information document needs to be considered by the Council for further action, the said Member State of Council should express its wish to have the information document translated in all six official languages, no later than five (5) calendar days after its publication on the Council website.

Travel, subsistence and insurance expenses

In accordance with No. 57 of the Convention of the ITU, "the travelling, subsistence and insurance expenses incurred by the representative of each Member State of the Council belonging to the category of developing countries, the list of which is established by the UNDP, in that capacity at Council sessions, shall be borne by the Union". Councillors may wish to contact the ITU travel section for more information at travel@itu.int or christine.marechal@itu.int.

Hotel accommodation

Reductions on hotel prices in Geneva have been obtained for delegates participating in ITU meetings. The list of the hotels concerned along with a reservation form **to be sent directly to the hotel** can be found at <u>https://www.itu.int/net4/travel/index.aspx</u>.
