DECISION 636

(Adopted at the inaugural Plenary Meeting)

Convening of the next ordinary plenipotentiary conference

The ITU Council,

noting

Resolution 77 (Rev. Bucharest, 2022) which provides that the next plenipotentiary conference (PP) shall be held in the last quarter of 2026 in Doha, Qatar,

decides

a) that, subject to the concurrence of the majority of the Member States of the Union, the next ordinary plenipotentiary conference will take place for a period of three weeks at the Doha Exhibition and Convention Center;

b) that the opening and closing dates of the conference will be from Monday, 9 November 2026 to Friday, 27 November 2026,

instructs the Secretary-General

to undertake a site visit and report to the 2024 session of the Council.
