Approval and deletion of ITU-T Recommendations

A. By TSB Circular 217 of 11 October 1999, it was announced that the following new ITU-T Recommendation was approved, in accordance with the procedures outlined in Resolution 1, Section 8, of the WTSC (Geneva, 1996):

- ITU-T Recommendation L.38: Use of trenchless techniques for the construction of underground infrastructures for telecommunication cable installation

The conditions governing the approval of ITU-T Recommendations were met and 21 Member States participating in the last meeting of Study Group 6 approved the text of this Recommendation during the Plenary session held on 24 September 1999.

B. By TSB Circular 213 of 23 August 1999, it was announced that the following ITU-T Recommendations were deleted, in accordance with the procedures outlined in Resolution 1, Section 8, of the WTSC (Geneva, 1996):

- ITU-T Recommendation F.160: General operational provisions for the international public facsimile services
- ITU-T Recommendation F.166: Service and operational requirements for a facsimile database service (FaxDB)
- ITU-T Recommendation F.180: General operational provisions for the international public facsimile service between subscribers' terminals (Telefax)
- ITU-T Recommendation F.182: Operational provisions for the international public facsimile service between subscribers with Group 3 facsimile terminals (Telefax 3)
- ITU-T Recommendation F.184: Operational provisions for the international public facsimile service between subscriber stations with group 4 facsimile Terminals (Telefax 4)
- ITU-T Recommendation T.65: Applicability of telematic protocols and terminal characteristics to computerized communication terminals (CCTs)
- ITU-T Recommendation T.200: Programmable communication interface for terminal equipment connected to ISDN

The conditions governing the deletion of ITU-T Recommendations were met and 11 Member States participating in the meeting of Study Group 8 (Geneva, 24 March – 1 April 1999) proposed to delete the text of these Recommendations. Eight Administrations of Member States responded to the consultation on 16 July 1999, and no objection to the deletion was received.

Assignment of Signalling Area/Network Codes (SANC) (ITU-T Recommendation Q.708)

Registration of domestic carriers for the allocation of ITU carrier codes (TSB Circular 191 of 31 May 1999)

CTITU B07 of 28.X.1999:

Registration of domestic carriers for the allocation of ITU carrier codes

Reminder: By TSB Circular 191 of 31 May 1999, the Director of the Telecommunication Standardization Bureau sent to the Administrations of Member States of the Union a copy of the Notification Form addressed to national regulatory authorities to request their help in the registration of domestic carriers for ITU carrier codes (ITU-T Recommendation M.1400).

As the number of carriers worldwide is growing rapidly, so the number of carriers in each country is increasing significantly and it is for this reason that the scope of the Recommendation M.1400 (previously aimed at the designation of international networks) is now changed to inter-operators' networks, including domestic interconnections. To achieve one integrated database for all connections, domestic network operators/service providers are therefore requested to register themselves with ITU for an ITU carrier code.

To overcome the difficulty for TSB in collecting and validating the related information directly from different domestic operators, it was thought necessary that national regulatory authorities should act as intermediary bodies for the purpose of registration of their domestic carriers.

Administrations/ROAs are kindly requested to duly complete the Notification Form (attachment to TSB Circular 191) and return it to ITU not later than *1 December 1999*.

Switzerland

Joint communiqué of 1.XI.1999:

– Swedish Telex Service

Telia AB, Stockholm (Sweden) and *Swisscom*, Berne (Switzerland) announce in this joint communiqué that, as from January 2000, Telia AB will no longer be handling telex traffic to and from Sweden, such traffic being handled instead by Swisscom. The Telex Switching Centre in Stockholm will be closed and all direct circuits to and from Stockholm will cease operation. All traffic destined for the Stockholm centre will have to be routed via the Telex Switching Centre of Swisscom in Lugano (Switzerland).

Swedish telex subscribers will remain connected to the telex network as at present. Their national telex numbers, together with the telex destination code (TDC) "54" allocated to Sweden under ITU-T Recommendation F.69 and the telex network identification code (TNIC) "S" allocated to Sweden under to ITU-T Recommendation F.68, will remain unchanged.

As from 10 January 2000, the responsibility for international rates and settlements will reside with Swisscom, which will handle direct all negotiations related to telex accounting rates. Telex traffic sent to or by Swedish subscribers shall be considered as Swiss traffic. The total accounting rates and rates division as applied in relations with Swisscom shall be applied also for telex traffic originating or terminating in Sweden. All administrations/ROAs are kindly requested to update their records accordingly.

Swisscom will handle the settlement of telex accounts, which will have to be done separately for telex traffic from/to Switzerland (telex destination code 45) and telex traffic from/to Sweden (telex destination code 54). Separate telex accounts should be sent to the following address:
