Note from TSB

In ITU Operational Bulletin No. 853 of I.II.2006, it was announced that, on the basis of discussions and agreements made at the 6-15 December 2005 Study Group 2 meeting, the Director of TSB assigned, within the international premium rate numbering resource of ITU-T Recommendations E.155 and E.169.2, the international charging indicator «0» and the numbering range 767 XXXXX jointly to the International Federation of Red Cross and Red Crescent Societies (IFRC) and the United Nations Children's Fund (UNICEF) for the purposes of raising funds by using the Short Message System (SMS) service of telephone networks.

The number to be implemented by operators was +979 0 767, followed by none or up to five digits.

However, on the basis of information received with regard to the implementation of this number, it appears that the codes in question were never used and indeed that the very concept has proven difficult to implement.

As a consequence, the Director of TSB is reclaiming the said codes +979 0 767 XXXXX, effective immediately.

Guinea-Bissau (country code +245)

Communication of 3.VII.2008:

The *Instituto das Comunicações da Guiné-Bissau (ICGB)*, Bissau, recalls implementation of a new National Numbering Plan (NNP) in Guinea-Bissau as from 6 July 2008.

In the fixed network of the new National Numbering Plan (NNP), the current fixed six (6)-digit numbering will be replaced by seven (7)-digit numbering. The number format for calls from abroad (structure of the international E.164-number) will be uniform for all the telephone networks (fixed and mobile): +245 XXX XXXX (seven (7)-digits) (CC + N(S)N, where CC is country code and N(S)N is National (Significant) Number).

The new numbering plan for fixed networks will be in use starting from 6 July 2008. In front of the existing fixed network N(S)N will be added digit "3".

For example, the current fixed network N(S)N XX XXXX (six (6)-digits) will be changed to 3XX XXXX (seven (7)-digits). Some localities, such as Ingoré, currently with N(S)N 33 XXXX, will completely change (see table overleaf).

No change will be made to the current seven (7)-digit mobile network numbering plan.
