Evolution of ICT Regulation

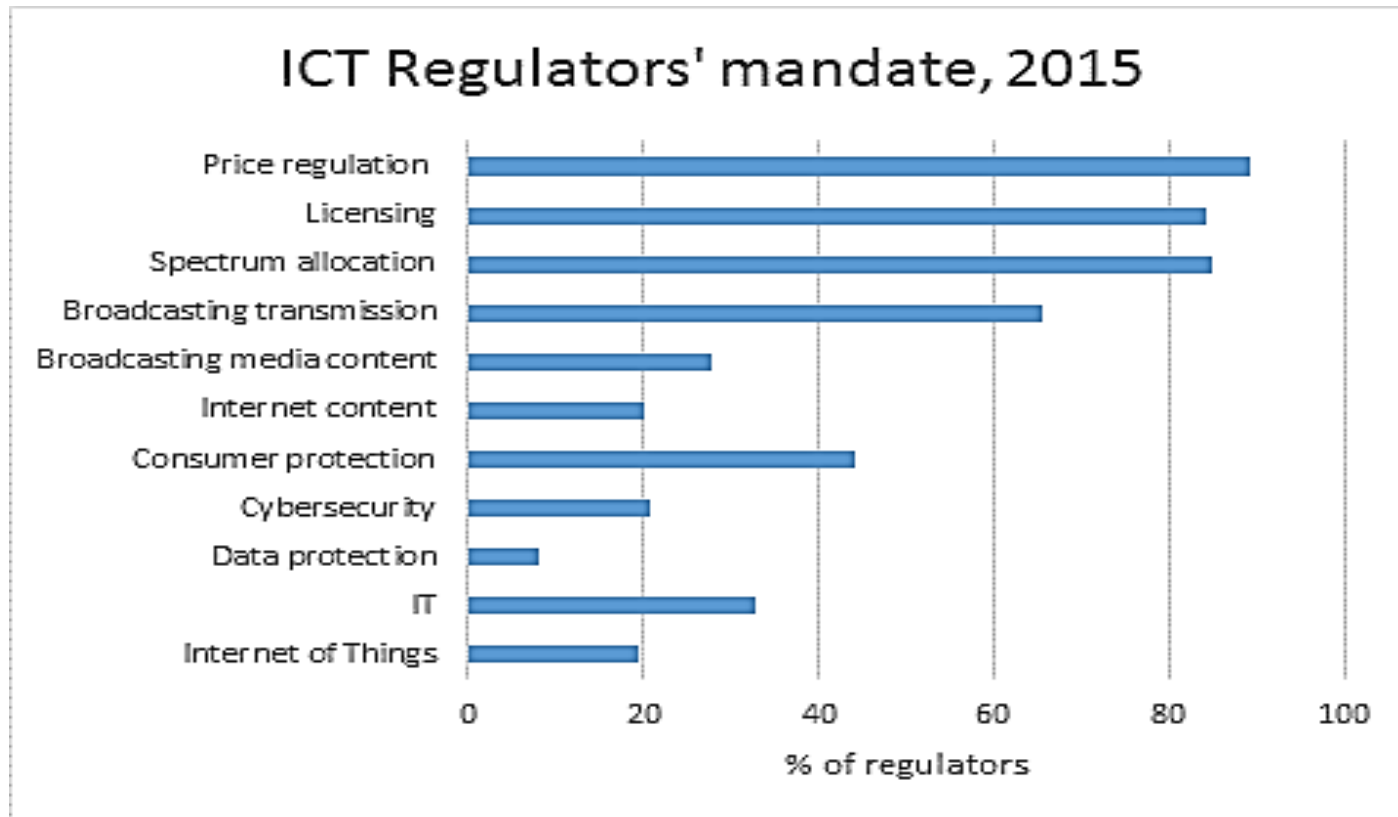

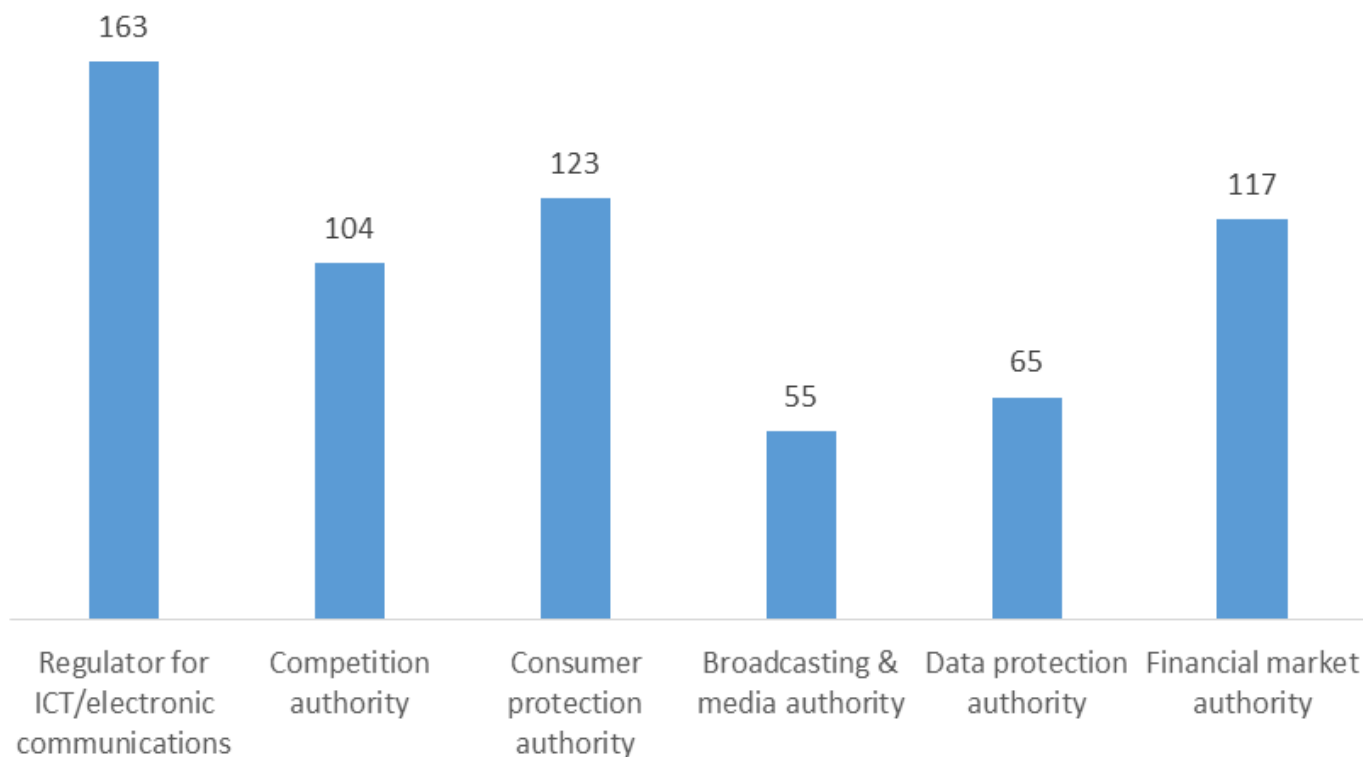

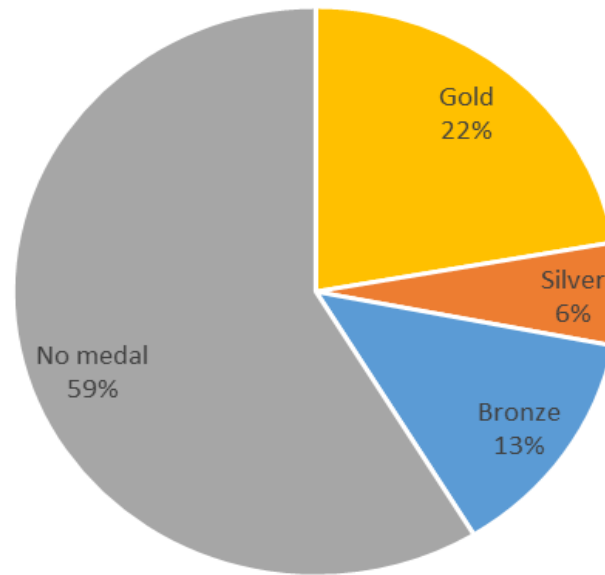

Silver medal (10 countries): No legal mandate but collaboration mechanisms in place.

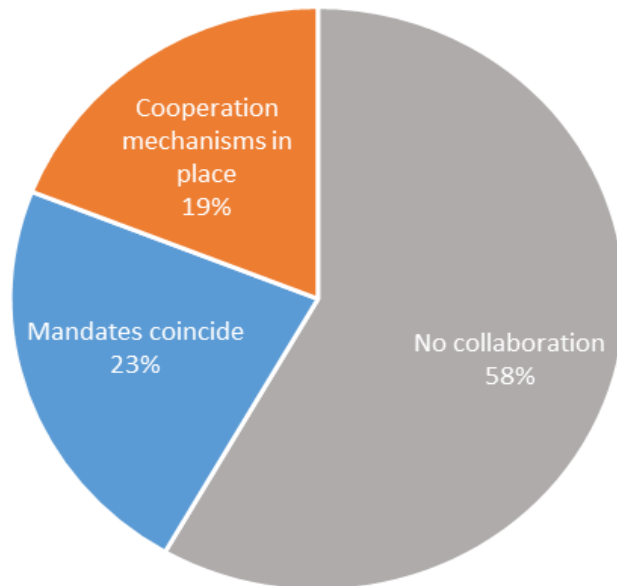
Bronze medal (25 countries): Mandates of both authorities allow for collaboration

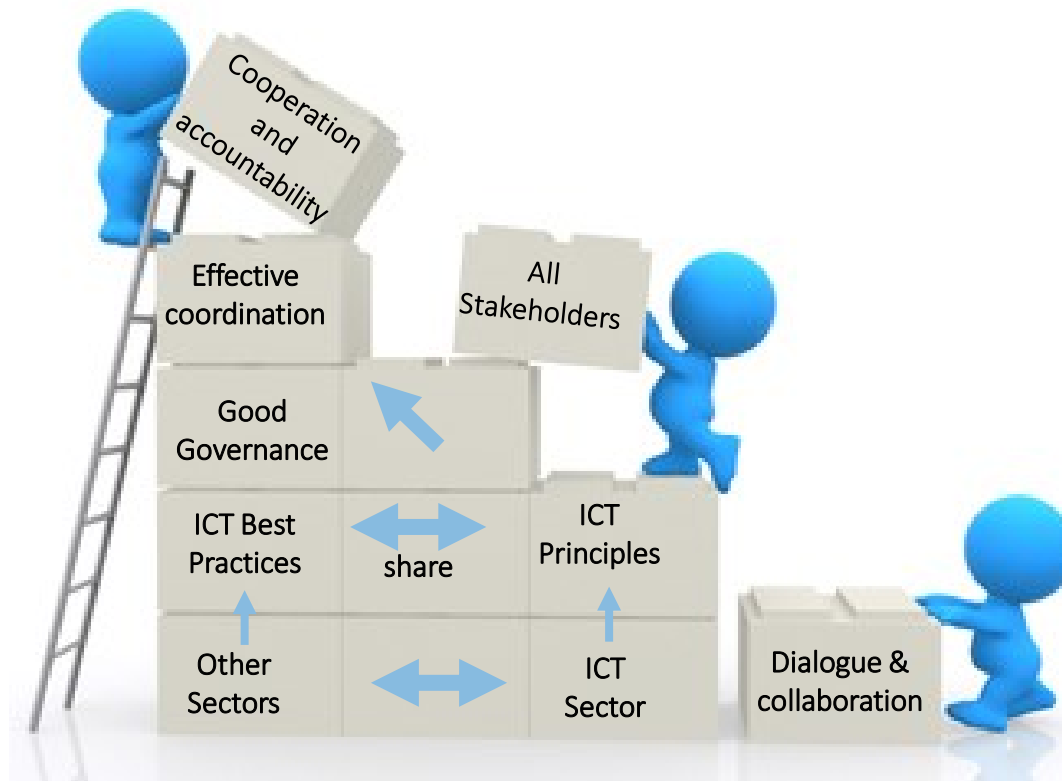

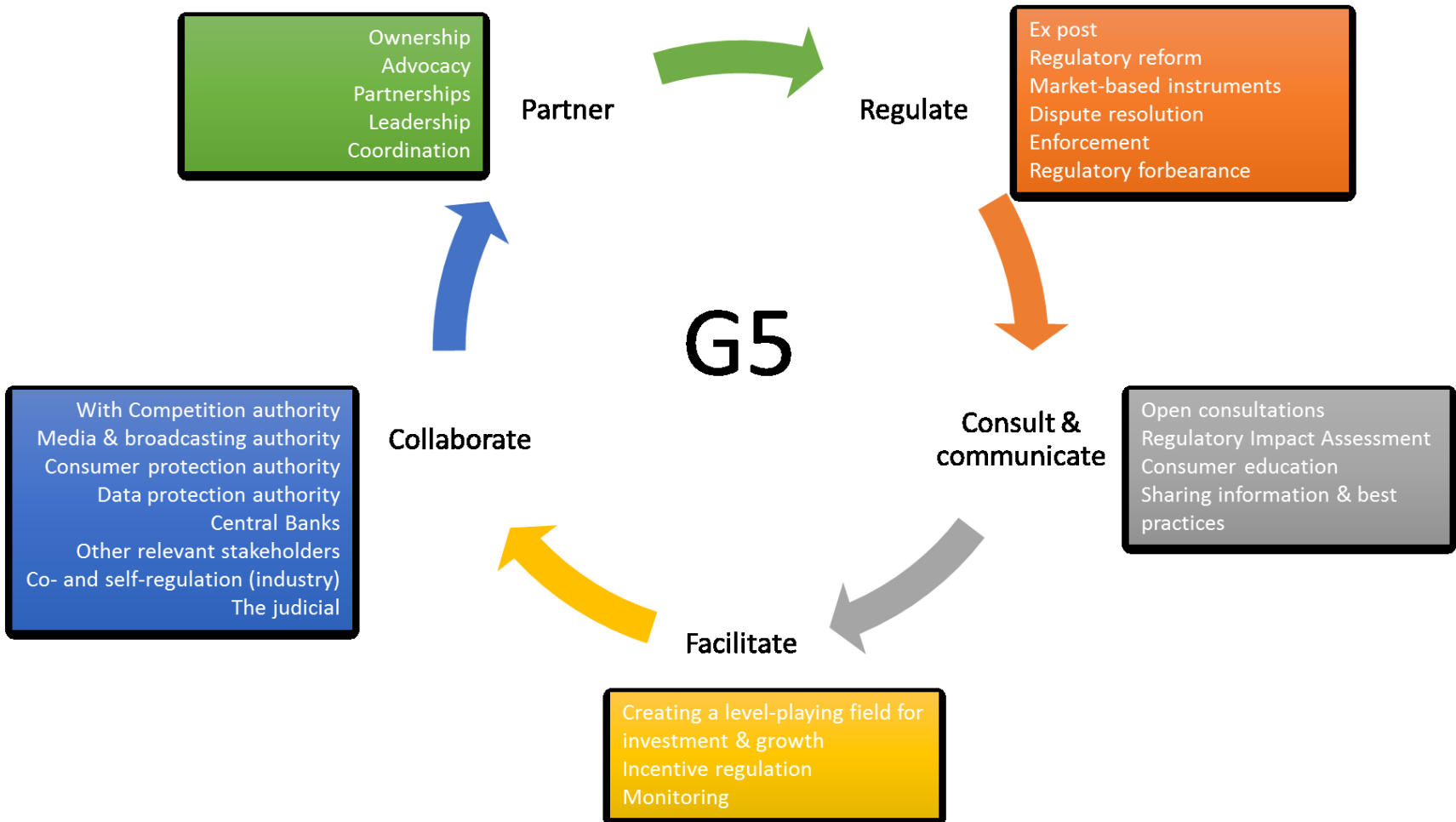


Building Blocks for Collaborative Regulation
