The Masterclass is being organized as a pre-event during <u>18th Asia Media Summit (AMS) 2023</u> which is organized by Asia-Pacific Institute for Broadcasting Development (AIBD) and hosted by Televisi Republik Indonesia (TVRI) from 21st to 25th May 2023 in Bali, Indonesia.

Fellowship

With support from the Department of Infrastructure, Transport, Regional Development and Communications and the Arts (DITRDCA) of Australia, ITU is pleased to provide **one full fellowship per eligible country of the Asia-Pacific region**, with a preference to those applicants who would be able to share expreiences relevant to the sessions of the Masterclass. Full fellowships will cover the air ticket (one return economy class ticket by the most direct/economical route from the country of origin to the meeting venue), and appropriate daily subsistence allowance.

In line with Plenipotentiary Resolution 213 (Dubai, 2018), it is encouraged that fellowship nominations take into consideration gender balance and inclusion of persons with disabilities and with specific needs. The criteria to grant a fellowship include: available ITU budget; active participation, equitable distribution among countries and sub-regions within Asia and the Pacific; application by persons with disabilities and specific needs; and gender balance.
