### **OPENING STATEMENT**

#### **CHECK-IN/CHECK-OUT**

Hotel check-in time is from **2 p.m.** Guests are asked to provide an estimated time of arrival at booking stage to assist the Hotel in preparing for their arrival. ### CANCELLATION

This fee will automatically be charged to the credit card given as guarantee or the prepaid deposit will be forfeited.

In the case of any company guarantee, related charges will be posted to the company credit card as provided or billed to the Company for settlement provided that we have a letter of approval/authorisation and credit facility has been established with the Hotel.

### **TERMINATION**

Either party may terminate this Agreement prior to the expiration of the term of this Agreement by delivering the other party a **30-day** written notice.

### **CAR PARK**

The parking underneath Vattanac Capital Tower is managed by a third party. Registered guests staying in a guestroom are entitled to unlimited complimentary parking for car only.

### FORCE MAJEURE CLAUSE

In the event that this Agreement cannot be performed due to causes that are outside the reasonable control of the Hotel or Group ("Force Majeure" causes, as defined below) and cannot be avoided by the exercise of due care, the affected Party may terminate this Agreement, upon written notice, without liability of any nature, and Hotel shall return any deposits. The following events constitute a Force Majeure, should any make performance under this Agreement illegal or impossible (including where it is illegal or impossible for Group to attend the Event): Acts of God, war, terrorist act, government regulation, strikes, riots, natural disaster such as earthquake, hurricane, tornado or cyclone, infectious disease outbreak, or any other cause beyond the Party's control. In the case of Force Majeure, whenever possible, the Group will in good faith make every effort to reschedule the event for a later date. Notwithstanding anything herein to the contrary, a change in economic circumstances sustained by either Party or a change in a Party's internal policies shall not constitute an event of Force Majeure.
