Registration and payment:

- a) Registration is made by e-mailing a completed Registration Form to the INFOFEST Organizer to: <u>office@biznislink.co.rs</u>.
- b) Deadline for the submission of Registration Form and payment is 14th September 2018.
- c) Registrations made and payments effected shall be irrevocable. Potential changes in terms of the names of participants and the type of room can be made latest by 21st September 2018, provided that the Organizer can accept them.
- d) Upon the receipt of the registration form, the Organizer will forward payment instructions (pro forma invoice) for the payments to be conducted in favour of the INFOFEST official operator the BTA Agency. A conducted payment shall have the meaning of the reservation confirmation, which will be valid until the expiration of the payment deadline indicated in a pro forma invoice. The failure to effect the payment within the indicated deadline shall immediately cancel the reservation and it needs to be renewed.
- e) If the payment is effected within the indicated deadline, the price cannot be changed.
- f) The participants making arrangements for their stay beyond the Organizer are obliged to be registered and pay the registration fee in the amount of 85.00 EUR.
- g) If the arrival and/or departure dates do not coincide with offered arrangement dates, you can directly contact the Organizer.
- h) At special requests the INFOFEST Organizer can provide individual transfer from/to the airports in Podgorica and Tivat and accommodation in other hotels in Budva.
