24-26 April 2019**

I am pleased to invite you to participate in the **ITU Workshop for Europe and CIS Regions “Using ICT to Save Lives”**, to be organized by the International Telecommunication Union (ITU) in collaboration with the A.S. Popov Odessa National Academy of Telecommunications (ONAT) of the Ministry of Education and Science of Ukraine, and held **in Odessa, Ukraine, from 24 to 26 April 2019**.

This workshop is organized in the context of the ITU Regional Initiatives, approved by the World Telecommunication Development Conference 2017 (WTDC-17). The outcomes of this meeting will contribute to the ITU Regional Initiative for Europe on “A citizen-centric approach to building services for national administrations” and the ITU Regional Initiative for CIS on “Monitoring the ecological status and the presence and rational use of natural resources”. This meeting will also offer an opportunity to present results of the [3<sup>rd</sup> Global Forum on Emergency Telecommunications \(GET-19\)](#) held from 6 to 8 March 2019 in Balaclava, Mauritius, and discuss the follow up at the regional level.

The workshop is addressed to the executives and experts responsible for emergency telecommunications and disaster response from ministries, regulators, telecom operators, universities and general education institutions, telecommunication equipment manufacturers, research and design institutes, software developers and other interested stakeholders from Europe and CIS regions. The workshop will focus on the following questions:

- Strategic aspects and international cooperation on emergency telecommunications and disaster response
- Best practices of using information and communication technologies (ICT) to save lives
- ICT-based solutions used in emergency situations
- Technical, legal and organizational aspects of telemedicine
- Using ICT to prevent climate change

The workshop will be conducted in English and Russian with simultaneous interpretation.
