I have the pleasure to invite you to participate in the Regional Regulatory Forum for Europe on **"Vision for Connectivity: Innovating the Future of Telecom Regulation and Security"**, which will be held from 23 to 24 September 2024 in Budva, Montenegro. The Forum will be co-organized by the International Telecommunication Union (ITU) and the Agency for Electronic Communications and Postal Services (EKIP) of Montenegro.

This Regional Forum will build upon the outcomes of the [Global Symposium for Regulators 2024](#) and its [Best Practice Guidelines](#). - Regulatory Strategies for Emerging Telecom Technologies
- Enhancing Quality of Service and Consumer Rights Protection
- Public-Private Partnerships and Submarine Cables
- Cybersecurity, Privacy, and Disaster Resilience

Representatives of European Regulatory Agencies, Ministries, Operators of Electronic Communications, Academia as well as representatives and experts of international organizations and institutions in charge of the regulation and development policy of electronic communications are invited to take part in this Forum.

All stakeholders are invited to participate as a panellist or a lecturer and are requested to kindly send the proposed title of their presentation by **5 September 2024** to conference@ekip.me (cc: eurregion@itu.int) and the presentation itself no later than **15 September 2024**.

Please note that the meeting will be paperless.
