

- IMPLEMENTING UNIVERSAL ACCESS PROGRAMS
- MANAGING RESOURCES LIKE NUMBERS AND RADIO SPECTRUM
- PROTECTING CONSUMERS AGAINST BAD BUSINESS PRACTICES, CYBER CRIMES AND VIOLATIONS OF DATA PRIVACY
- SAFE-GUARDING NATIONAL INTERESTS

TELECOM STATISTICS

- FIXED-TELEPHONE SUBSCRIPTIONS (2018) 2.206
- MOBILE-CELLULAR TELEPHONE SUBSCRIPTIONS (2018) 1.309.068
- ACTIVE MOBILE-BROADBAND SUBSCRIPTIONS (2018) 400.850
 FIXED-BROADBAND SUBSCRIPTIONS (2018) 3.500











SERVICE COVERAGE

- 95.5 % OF THE POPULATION COVERED BY A MOBILE-CELLULAR NETWORK
- 95.5 % OF THE POPULATION COVERED BY AT LEAST A 3G MOBILE NETWORK
- 40 % PERCENTAGE OF THE POPULATION COVERED BY AT LEAST AN LTE/WIMAX MOBILE NETWORK
