On behalf of the International Telecommunication Union (ITU), I am pleased to invite you to participate in the **ITU Regional Workshop for CIS: "ITU Virtual Laboratory for Remote Tests of Equipment, New Technologies and Services"** to be held in Moscow, Russian Federation from 10 to 12 November 2014.

The Workshop is organized by the Telecommunication Development Bureau in cooperation with the Ministry of Telecom and Mass Communications of the Russian Federation, with the support of the Federal State Unitary Enterprise Central Science Research Telecommunication Institute (ZNIIS) in the framework of the implementation of the CIS Regional Initiative approved by the 2010 World Telecommunication Development Conference (WTDC-10, Hyderabad, India).

In particular, the following issues will be covered:

- *Infrastructure of the virtual laboratory for remote tests of the possibility to provide Triple Play and other services;*
- *Infrastructure of the real network equipment of the leading world manufacturers training on working with it;*
- *Infrastructure of virtual laboratory for research of the issues of information security and obtaining relevant working skills;*
- *Use of Spirent TestCenter SPT-N4U-220; IXIA 400T; AMULET IP connection former, PRIZMA telephone connection former, STT-7000 universal module analyzer; analyzer of protocols OKCNø7 u EDSS A8619;*
- *Hardware and software solution for measurement of the Internet access speed;*

- *Web portal of the Virtual Laboratory;*
- *Knowledge date base of the Virtual Laboratory.*

The Workshop will be conducted in Russian with simultaneous interpretation into English. It will be paperless.
