


Importation of Telecommunication equipment for Personal use

- Type approved equipment are allowed
- Required Docs
- Application Form
- Invoice/ Detention Receipt/ Air way Bill /Parcel Receipt
- Technical Specification of the equipment
- Copy of the National ID/ Passport/Driving License
- If someone else need to get the approval on behalf of a person, the Authorization letter and the copies of the National ID/ Passport of both persons

Bulk Importation of Telecommunications equipment

- Import, manufacture, sell, offer for sale, deal in, hire, transfer, Install require Section 21 Licence (Vendor Licence)
- · Annually renewable





Type Approval of Mobile Phones/Modem/Data device

- · Technical details of the mobile phone / data modem / data device
- The certificate of the Declaration of Conformity (DOC) from the Manufacturer stating that the mobile phone/data modem/data device complies with the essential requirements of Article 3 of the R&TTE 1999/5/EC Directive
- Notified Body Statement of Opinion as per Annex IV of the R&TTE 1999/5/EC Directive

or China Compulsory Certification (CCC) and China SRRC Certification

 Specific Absorption Rate (SAR) Report of the mobile phone/data modem/data device. Limit 2 W/Kg for 10g of tissue

The TAC (IMEI) of the mobile phone/data modem/data device. (The "Marketing Name" and the "Manufacturer" of the mobile phone/data

Procedure

- Applications for type approval should be made in the form issued for that purpose by the TRCSL (Commission).
- permission will be granted to import a sample unit.
- Complete set of sample mobile phone/data modem/data device (Original box, Accessories, User Guide, etc) along with the relevant documents and completed type approval application form should submit to the Commission.
- Any future changes in models, design etc. will require fresh type approval from the Commission.
- Complete records of the importation should be submitted to the Commission in the form issued for that purpose.

- TRCSL Approval
- Controller of Import and Export
- Department of Customs

TRIVES established by TRCSL

- FOR VERIFICATION OF GENUINE PHONES
- Fifteen digits International Mobile Equipment Identity (IMEI) .
- It can be displayed on the screen of the phone by entering *#06# in to the keypad on mobile phone.
- The IMEI number of a mobile phone can be verified by sending a SMS to 1909 in the following format.

IMEI (space) 15 digit IMEI number
