# WISFAT



- A secured web interface to submit notices to the Bureau.
  - Who has access to this interface?
    - Only registered notifiers nominated by their administration
    - Must have a TIES account
    - One or many notifier(s) per administration
    - Responsibility of the administration to inform the Bureau of any changes regarding the registered notifier(s)
  - Which notice types can be submitted?
    - All notice types, such as for recording in the Master Register, modification to Plans and notification for the seasonal planning of HF bands (Article 12)
    - **Except notifications for List IV (Coast stations), List V (Ship stations) and List VIII (Monitoring stations)**
  - Automatic acknowledgment e-mail is sent by the system to the address specified by the user



# How to become a registered notifier?



- Administration selects the notifier(s)
- The selected notifier(s) must have a TIES account
- Request a TIES account via the web site

- Select “Request a TIES account”
- Make sure that the TIES focal point is still active within your Administration, if not inform the Bureau
- Your TIES focal point must approve your request
- The administration must send an official e-mail request to the BR (brmail@itu.int)
  - Name, position, service e-mail, TIES Username
- BR will inform the notifying administration with the latest list of notifiers
