ART-11 Importance of notification


- Inform others of the bringing into use of a frequency assignment.
- Recording in the MIFR results in rights and obligations for the notifying Administration

Art.11 non Plan > 28 MHz

- Publication in BRIFIC Part 1
- Examination w.r.t. 11.31 only
- Publication in Parts 2 or 3
- Objections to Publication not receivable
- •In Case of interference Administrations can apply procedures of Article 15.

Art.11 for Plans

- First complete the Plan modification procedure (Plan Art.4) using proper form.
 - Publication in Part A of a Special Section (SS).
 - Comment period(16 weeks, 100 days, etc)
 - Administration requests publication in Part B.
 - BR publishes the modifications in Part B of SS and the frequency assignments are entered in to the Plan.

Art.11 LF/MF (GE75 / RJ81) parameters same as Plan

- •Form TB7
- Publication in BRIFIC Part 1
- •Examination w.r.t. 11.31 and 11.34
- Publication in Parts 2 or 3

Art.11 LF/MF (cntd)

- •Full forms must be used for:
 - Slight changes to Plan parameters (GE75/RJ81)
 - Modification of MIFR entry
 - Notification of RJ88 assignments
- Procedure of Article 5 of the Agreements
- Site tolerances of Art.4 accepted

GE06 MODIFICATION/NOTIFICATION

Art.11 VHF/UHF GE89 rev.2006

- Modified in 2006, Plan now has only the following bands:
 - •- 47 68 MHz
 - •- 230 238 and 246-254 MHz
- •Procedure described in Article 5 of the GE89 rev.2006 Final Acts.
 - •***No notifications since 2006***

GE06 MODIFICATION/NOTIFICATION Art.11 VHF/UHF ST61 rev.2006

Modified in 2006, Plan now has only the following

bands:

FREQUENCY	NOTES
BANDS	
47-68 MHz	FM + TV
87.5-100 MHz	TV only
162-174 MHz	TV only

Procedure described in Article 5 of the ST61 rev.2006 Final Act.

Very few notifications since 2006


Notice type	Applicable for
TB2	Article 5 identical characteristics as in Plan
T01	Slight changes to Plan parameters or MIFR mod.

- Procedure of Article 5 of the GE84 Final Acts.
- Site tolerances of Article 4 are permitted.
- Large number of notifications (>1100 in 2008)



TB2	Article 5 identical characteristics as in Plan	5.1.2 a)
G02	Article 5 analogue within the envelope of a digital broadcasting plan entry	5.1.2 a)
GS1	Article 5 T-DAB, Plan remarks	5.1.2
GT1	Article 5 DVB-T, RPC or Plan remarks	5.1.2
GB1	Article 5 Broadcasting (not analogue) within the envelope of a digital broadcasting Plan entry	5.1.3


GE06 Article 5 flowchart



Regular assignment - 5.1.2 a) b) (1 of 2)




Regular assignment - 5.1.2 a) b) (2 of 2)




GE06 MODIFICATION/NOTIFICATION Different characteristics within


