### Overview of BSG

#### **Bridging the Standardization Gap**

- BSG is one of strategic goals of ITU-T
- Defined as the disparities in the ability of developing countries, relative to developed ones, to access, implement, contribute to and influence international ICT standards, specifically ITU-T Recommendations.


Bridging the standardization gap: PP Res 123, WTSA Res 44 and WTDC Res 47

#### **The Standards Gaps**

- Lack of Understanding of the National Importance of Standards
- Relatively Less Private Industry Involvement in Standards
- Inadequate Funding of Standardization
- Insufficient Standardization Human Resources
- Insufficient Involvement in International Standards Development Processes
- Inadequate Technical Infrastructure for Standards Participation

#### **National Standards Capability**

Four Levels of National Standards Capability



#### **Addressing the Standardization Gap**

- Disparities between developed and developing countries in standardization have 5 main components:
  - disparity of voluntary standardization,
  - disparity of mandatory technical regulations
  - disparity of conformity assessment,
  - disparity in human resources skilled in standardization
  - disparity in effective participation in ITU-T activities

#### **Africa Proposals to WTSA 12**

- Coordination and support from ITU regional offices to Regional Groups
- Facilitation of participation of Industry and Academia from Africa
- Support for participation and contributions to Study Groups
- To able to create Regional Standardization bodies as an umbrella to Regional Groups

#### WTSA 12 Resolution 44

further resolves that ITU regional offices

be engaged in the activities of TSB in order to promote and coordinate standardization activities in their regions to support the implementation of the relevant parts of this resolution and to carry out the objectives of the action plan, and launch campaigns to attract new Sector Members, Associates and Academia from developing countries to join ITU-T;

#### Action Point to ITU Regional Office

To provide contact person to the Regional Groups similar to Advisors from TSB

further resolves that ITU regional offices

- assist the vice-chairmen, within the offices' budgets, in mobilizing members within their respective regions for increased standardization participation;
- organize and coordinate the activities of the regional groups of ITU-T study groups;

#### Action Point to Vice Chairmen:

To consider to promote standardization activities and mobilize members at sub-regional groups such as CRASA, EACO, UEMOA, WATRA, etc

further resolves that ITU regional offices

- 4 provide the necessary assistance to the regional groups of ITU-T study groups;
- provide assistance to the regional telecommunication organizations for the setting-up and management of regional standardization bodies,

#### Action Point to Vice Chairmen:

To form a conclave to come out with the terms of reference for the setting up and management of a regional standardization body

invites regions and their Member States

- to pursue the creation of regional groups of parent ITU-T study groups in their respective regions in accordance with resolves 5 of this resolution and Resolution 54 (Rev. Dubai, 2012) of this assembly, and to support their meetings and activities, as appropriate, in coordination with TSB;
- to take an active part in the activities of the ITU-T regional groups and support regional organizations in setting up regional frameworks for the development of standardization activities;

#### <u>Action Point to Member Countries:</u>

To elevate the ToR from Vice Chairmen to Africa Union Ministerial session

invites regions and their Member States

to create regional standardization bodies, as appropriate, and encourage joint and coordinated meetings of such bodies with the regional groups of the ITU-T study groups in the respective regions, so that these standardization bodies act as an umbrella for such regional group meetings;

#### Caution to Member Countries:

To avoid conflicts of regional standardization body and parent Study Group

encourages Member States and Sector Members to take the objectives set out in the action plan in the annex to this resolution into account in their participation in ITU T.

Objective II Assisting developing countries in:

- •Ensuring that developing countries have a clear understanding of ITU T Recommendations.
- •Enhancing the application of ITU T Recommendations in developing countries.

To increase the human resources capacity of developing countries in ITU-T and national standardization activities.

- Mentoring programme for newcomers to Study Groups
- Mentor role in study group
- Research on measuring and reducing the standardization capability gap
- Free access to ITU-T Standards
- Increase remote participation and collaboration
- Reduced fees (CHF 3,975) for developing countries including academia
- Study on assessing the standardization capability of developing countries

## Strengthen Standard Making Capability

#### New Actions From WTSA-12

- Developing guidelines to assist developing countries in their involvement in ITU-T activities.
- Improving procedures and electronic tools for remote participation.
- Conducting consultancy projects designed to support developing countries in the development of standardization plans
- Studies on ICT innovations and standardization in developing countries



## **Assist Developing Countries in Standards Implementation**

#### New Actions From WTSA-12

- Assist developing countries to
  - Establish a standardization secretariat to coordinate standardization activities and participation in ITU-T study groups
  - Determine whether their existing national standards are consistent and in accordance with the current ITU-T Recommendations
- Develop implementation guidelines for new ITU-T Recommendations
- Enhance Standards Q&A Forum (webinars to be held before each Study Group meeting)
- E-learning courses on ITU-T Recommendations

#### **Develop Human Resources**



#### **Develop Human Resources**

- In-depth technical tutorials on ITU-T Recommendations
- Increase number of officials (Chairs / Rapporteurs) from developing countries in ITU-T Study Groups
- E-learning course on ITU-T Meeting Procedures (ITU-T A.1) NEW!
- New Actions From WTSA-12
  - → Fellowships to be provided under TSB budget to eligible countries to attend relevant ITU-T meetings.
  - ◆ Encouraging secondment and short-term employment opportunities for developing countries experts in test laboratories of international standards development organizations (SDOs) and manufacturers, in particular in the area of conformance and interoperability testing

resolves


