

The mechanism and structure of modern pool licenses was created to promote the MPEG 2 video standard into the market in 1993-1997




Implementers Royalty(total)= $R(A)+R(B)+R(C)+R(D)+R(E)+\cdots+R(X)$

It's impossible to predict or estimate final accumulate royalty amount. However, easy to predict a lot of time and money is required for license negotiations.



- Minimize SEP risk by establishing MPEG2 FRAND benchmark
- Adequate award to SEP owners
- Establish Level Playing Field in MPEG2 market
