On behalf of the International Telecommunication Union (ITU), we would like to invite your organization to participate in a workshop on "Spectrum Management - Digital Migration, Digital Dividend" for English speaking countries in Africa, to be held in Kigali, Rwanda, from 25 to 29 July 2011. The workshop will be hosted by Kigali Institute for Sciences and Technologies (KIST).
