

ROADMAP FOR INTERNATIONAL STAKEHOLDERS

The [International Conference on #Cyberlaw, #Cybercrime & #Cyber Security](#) was held at New Delhi on 20th November, 2014, and was organized by [Cyberlaws.Net](#) and [Pavan Duggal Associates](#), Advocates, [Supreme Court of India](#).

The International Conference on #Cyberlaw, #Cybercrime & #Cyber Security saw intense deliberations taking place on variety of issues concerning #Cyberlaw, #Cybercrime & #Cyber Security. There was unanimity among stakeholders that three subjects of #Cyberlaw, #Cybercrime & #Cyber Security play an extremely significant role in not just the development of the Internet but also in the way nations and other stakeholders in the world would conduct their activities in the digital and mobile ecosystems.

The International Conference on Cyberlaw, Cybercrime & Cybersecurity recommended a roadmap for the international stakeholders moving forward:-

- 1. The International Conference on #Cyberlaw, #Cybercrime & #Cyber Security recommended that countries must join hands in further discussing common rules of the road ahead for international cooperation in Cyberlaw, Cybercrime and Cybersecurity.**
- 2. The Conference recommended formation of the Permanent Standing Committee on #Cyberlaw, #Cybercrime & #Cyber Security. The said Committee will be established under the aegis of the International Conference on #Cyberlaw, #Cybercrime & #Cyber Security. The Permanent Standing Committee will aim to discuss, deliberate and advise various stakeholders on various emerging trends in #Cyberlaw, #Cybercrime & #Cyber Security.**
- 3. It was recommended that strategies must be adopted by national governments to address the critical challenges of the Dark Net and further create more capacity building and awareness amongst law enforcement agencies.**
- 4. The Conference recommended that #Cyberlaw, #Cybercrime & #Cyber Security study should be made mandatory as integral part of school curriculums/education systems.**
- 5. The creation of #Cyberlaw, #Cybercrime & #Cyber Security Hall of Fame where prominent personalities who have remarkably contributed in their respective fields, would be inducted, was recommended.**
- 6. The Conference called upon the international institutions stakeholders to contribute to further evolution of jurisprudence in #Cyberlaw, #Cybercrime & #Cyber Security.**

- 7. The conference further recommended that all stakeholders in cyber ecosystem needs to work towards inculcating the culture of cyber security amongst all relevant stakeholders.**
- 8. The conference unanimously recommended world governments to constantly work to improving and enhancing their legal frameworks to deal with issues pertaining to cyberspace and cyber terrorism.**
- 9. The conference recommended to create a network for cyber legal professionals across the world who are working in the area of Cyberlaw and Cybercrime which could then be tapped not just by the International Conference on Cyberlaw, Cybercrime & Cybersecurity but also by other interested stakeholders in the digital and mobile ecosystem.**
- 10. The Conference recommended that there is a need to work on the complicated issue pertaining to jurisdiction and connected jurisprudence.**
- 11. The Conference further recommended that distinguished eminent persons in Cyberlaw, Cybercrime and Cybersecurity be invited to contribute their thought process of how the future jurisprudence in Cyberlaw, Cybercrime and Cybersecurity is likely to evolve.**
