However, we were not to be deterred. In the midst of the fighting and obstacles SRI LANKA DID NOT WAVER its commitment to her People and to the International Community. All Governments that ruled us since then, should be commended for meeting our International obligations and commitments.

At present, we have stopped the fighting that ravaged our Country for the past 20 years and are discussing peace with the Liberation Tigers of Tamil Eelam, better known as the L.T.T.E. We are optimistic that we can

establish a durable peace in Sri Lanka and thereafter accelerate our development to better the conditions of our People.

Dear Delegates, at present I am on the verge of presenting to our Cabinet of Ministers, a NEW COMMUNICATIONS POLICY for adoption and implementation very soon. As you all are aware

Convergence of Technologies and Methods are happening all the time. We in Sri Lanka too, are conscious of these changes and are adapting to these new necessities.

This Policy, when implemented will ensure that Sri Lanka is fully compliant with international thinking on Communication which will help develop our Country to face the challenges of the present and the future.

We too, fully endorse the Secretary-General, Mr. Utsumi's view that we all have to device ways and means to REACH THE UNREACHED. All those present here are erudite professionals and are fully aware of our commitment to providing UNIVERSAL ACCESS to all the peoples of the world.

Therefore, I would suggest that the I.T.U., while implementing the formal commitments expected of them, that they URGENTLY AND

EFFECTIVELY draw up SHORT TERM AND LONG TERM Strategies to address the serious issue of providing UNIVERSAL ACCESS.

Perhaps, a Special Fund could be created to assist such activities and assistance and subsidies could be provided on a NEEDS BASIS. If we succeed in our efforts, it will have a direct bearing on the well-being of the peoples of the world and a mission of the I.T.U. will be achieved.

In conclusion, Dear delegates, may I add that SRI LANKA seeks a position in the I.T.U. Council in REGION 'E', that is ASIA AND AUSTRALASIA at this PLENIPOTENTIARY and we seek your mandate. to make our dream a REALITY.

In conclusion, I wish to covey my Personal commitment and Sri Lanka's unstinted co-operation to make a success of your efforts.
