### **Occasional provision of circuits for international sound- and television-programme transmissions**

#### **Amendment 1**

#### **Summary**

This Amendment to ITU-T Rec. D.180 contains changes relevant to clause 7.2 and a new clause 7.2.1.

#### **Source**

Amendment 1 to ITU-T Recommendation D.180 (2002) was approved on 4 June 2004 by ITU-T Study Group 3 (2001-2004) under the WTSA Resolution 1 procedure.

## FOREWORD

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications. The ITU Telecommunication Standardization Sector (ITU-T) is a permanent organ of ITU. ITU-T is responsible for studying technical, operating and tariff questions and issuing Recommendations on them with a view to standardizing telecommunications on a worldwide basis.

The World Telecommunication Standardization Assembly (WTSA), which meets every four years, establishes the topics for study by the ITU-T study groups which, in turn, produce Recommendations on these topics.

The approval of ITU-T Recommendations is covered by the procedure laid down in WTSA Resolution 1.

In some areas of information technology which fall within ITU-T's purview, the necessary standards are prepared on a collaborative basis with ISO and IEC.

## NOTE

In this Recommendation, the expression "Administration" is used for conciseness to indicate both a telecommunication administration and a recognized operating agency.

Compliance with this Recommendation is voluntary. However, the Recommendation may contain certain mandatory provisions (to ensure e.g. interoperability or applicability) and compliance with the Recommendation is achieved when all of these mandatory provisions are met. The words "shall" or some other obligatory language such as "must" and the negative equivalents are used to express requirements. The use of such words does not suggest that compliance with the Recommendation is required of any party.

## ITU-T Recommendation D.180

### Occasional provision of circuits for international sound- and television-programme transmissions

#### Amendment 1

##### 1) Clause 7.2 Remuneration of Administrations

*Modify clause 7.2 as follows:*

The Administration with which the order for the provision of circuits is placed is responsible for the remuneration of all other Administrations involved. For this purpose, all such other Administrations should send to the Administration responsible for collecting charges the relevant details concerning the provision of the circuits and the amounts corresponding to their credits with monthly ~~documents, or, if required, as soon as possible by facsimile or telex~~ invoices.

The invoices should additionally contain:

- Address of debtor's Administration;
- Address of creditor's Administration;
- Bank contacts;
- Name of the bank;
- Address of the bank;
- Account number;
- SWIFT code;
- IBAN (International Banking Account Number).

##### 2) New clause 7.2.1

*Insert new clause 7.2.1 as follows:*

7.2.1 The debtor's Administration is entitled to reject incomplete invoices which do not contain the data defined in 7.2. These invoices will be returned for correction to the creditor's Administration.
