#### Summary

Recommendation ITU-T Q.4001.3 v.1 (2016) specifies Part 3 of the abstract test suite (ATS) and partial protocol implementation extra information for testing (PIXIT) proforma specification on the network side for testing compliance to Recommendation ITU-T Q.3403 v.1.

The version number, v.1, indicates that this is version one of Recommendation ITU-T Q.4001.3, and that it relates to Release 10 of the relevant 3GPP/ETSI standard.
