#### **Transport of Voice Enhancement Device related information**

##### **Summary**

This amendment was produced to meet the need for the transport of Voice Enhancement Device/Function related information. This amendment contains the modifications to ITU-T Rec. Q.762 (1999) in order to accommodate these needs. This amendment should be read in conjunction with Amendment 5 to ITU-T Rec. Q.763, and Amendment 5 to ITU-T Rec. Q.764.

##### **Source**

Amendment 4 to ITU-T Recommendation Q.762 (1999) was approved on 13 September 2006 by ITU-T Study Group 11 (2005-2008) under the ITU-T Recommendation A.8 procedure.

## FOREWORD

The International Telecommunication Union (ITU) is the United Nations specialized agency in the field of telecommunications. The ITU Telecommunication Standardization Sector (ITU-T) is a permanent organ of ITU. ##### 1) Clause 1.4 – Abbreviations

*Insert the following new abbreviation alphabetically:*

VED Voice Enhancement Device

##### 2) Clause 3 – Signalling parameters

*Add the following definition to clause 3:*

**3.103 VED information:** Information sent in either direction giving information about the inclusion of a voice enhancement device in the call.

##### 3) Clause 4 – Parameter information

*Add the following definition to clause 4:*

**4.163 VED:** Information indicating if acoustic echo control and/or noise reduction has been included in the bearer.
